**to Reflect Legal Name Changes of Enrolled Members)**

**RESOLUTION NO. 26-017**

1   **WHEREAS,**     the Tohono O'odham Legislative Council is vested with the power to enact laws  
2                   and ordinances governing the enrollment and adoption of members  
3                   (Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and  
4                   Article VI, Section 1(h)); and

5   **WHEREAS,**     pursuant to Articles VI and VII of the Nation's Enrollment Ordinance, the  
6                   Enrollment Committee shall review membership applications and make a  
7                   written recommendation to the Tohono O'odham Legislative Council to approve  
8                   or reject the application (14 Tohono O'odham Code Chapter 1 – Enrollment  
9                   Ordinance); and

10   **WHEREAS,**    pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono  
11                   O'odham Legislative Council shall determine eligibility for membership or  
12                   adoption; and

13   **WHEREAS,**    the Enrollment Program has received official documents reflecting the legal  
14                   name changes of enrolled members as a result of marriage, divorce, legal  
15                   adoption, or for other reasons; and

16   **WHEREAS,**    the Enrollment Committee recommends that Resolution Nos. 93-360, 07-075, 18-  
17                   098 and 25-190 be amended to reflect the legal name changes of members  
18                   identified in the January 2026 Legal Enrollment Resolution Summary, which is  
19                   incorporated by this reference.

20   **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution  
21                   Nos. 93-360, 07-075, 18-098 and 25-190 are amended upon the effective date of  
22                   those resolutions to reflect the legal name changes of members identified in the  
23                   January 2026 Legal Enrollment Resolution Summary.


24   The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup>  
25   day of JANUARY 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; ~~-0-~~  
26   AGAINST; ~~-0-~~ NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
27   Article II, Sections 1 and 2 and Article VI, Section 1(h) the Constitution of the Tohono O'odham  
28   Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting  
29   Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
30   16 of the Act of June 18, 1934 (48 Stat.984).






