

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Enrollment Resolution Nos. 07-706, 07-236, 08-682, 09-369, 09-614,  
10-070, and 11-566 to Correct Names of Enrolled Members)**

**RESOLUTION NO. 26-018**

**WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws and ordinances governing the enrollment and adoption of members (Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and Article VI, Section 1(h)); and

**WHEREAS, pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the Enrollment Committee shall review membership applications and make a written recommendation to the Tohono O'odham Legislative Council to approve or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment Ordinance); and**

**WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono O'odham Legislative Council shall determine eligibility for membership or adoption; and**

**WHEREAS,** the Enrollment Program has determined that a number of resolutions approving membership and adoption applications misspelled or incorrectly listed the names of members; and

**WHEREAS,** the Enrollment Committee recommends that Resolution Nos. 07-706, 07-236, 08-682, 09-369, 09-614, 10-070, and 11-566 be amended to reflect the correct name for the members identified in the attached January 2026 Corrected Enrollment Resolution Summary, which is incorporated by this reference.

**NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution Nos. 07-706, 07-236, 08-682, 09-369, 09-614, 10-070, and 11-566 are amended upon the effective date of those resolutions to reflect the correct names of members identified in the January 2026 Corrected Enrollment Resolution Summary.

**The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup> day of JANUARY 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article II, Sections 1 and 2 and Article VI, Section 1(h) the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
