

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution No. 25-397 "Approving Enrollment Applications
for Membership into the Tohono O'odham Nation for November 2025,"
to Delete a Member Approved Twice)

RESOLUTION NO. 26-019

1 **WHEREAS**, the Tohono O'odham Legislative Council is vested with the power to enact laws
2 and ordinances governing the enrollment and adoption of members
3 (**Constitution of the Tohono O'odham Nation, Article VI, Section 1(h)**); and

4 **WHEREAS**, Articles VI and VII of the Nation's Enrollment Ordinance provide that the
5 Enrollment Committee is responsible for reviewing enrollment applications and
6 making recommendations to the Legislative Council regarding the eligibility of
7 applicants (**Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1**); and


8 **WHEREAS**, the Enrollment Program has determined that a member, as identified in the
9 attached Amending Enrollment Resolution List for January 2026 and
10 incorporated by this reference, was approved for membership by Resolution No.
11 17-579 and was approved a second time by Resolution No. 25-397; and

12 **WHEREAS**, the Enrollment Committee recommends that Resolution No. 25-397 be amended
13 to delete the member identified in the Amending Enrollment Resolution List for
14 January 2026.

15 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution
16 No. 25-397 is amended upon the effective date of that resolution to delete the
17 member and corresponding information identified in the Amending Enrollment
18 Resolution List for January 2026 and the member identified therein shall retain
19 the roll number and approval date identified in Resolution No. 17-579.

20 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14th
21 day of JANUARY 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0-
22 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
23 Article II, Sections 1 and 2 and Article VI, Section 1(h) the Constitution of the Tohono O'odham
24 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting
25 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
26 16 of the Act of June 18, 1934 (48 Stat.984).


