

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Monthly Age 18 Report for January 2026 of Tohono O'odham Eligible**  
**Minor Members and Authorizing Distribution of the Per Capita Payments and**  
**Interest Held in Trust on Their Behalf by Principal Trust Company)**

**RESOLUTION NO. 26-021**

1       **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Tohono O'odham**  
2       **Legislative Council with the power to "manage any funds within the exclusive**  
3       **control of the Tohono O'odham Nation, including proceeds derived from lands**  
4       **and resources of the Tohono O'odham Nation, and to appropriate these funds for**  
5       **the benefit of the nation and its members" (Constitution, Article VI, Section**  
6       **1(d)(2)); and**

7       **WHEREAS, disbursement of the 2020 Non-Gaming Per Capita payment to each eligible minor**  
8       **Tohono O'odham member is contingent upon certification of the member's**  
9       **eligibility and compliance with the Trust Agreement of the Nation for the benefit**  
10       **of minor eligible members, which establishes interest bearing accounts on**  
11       **behalf of the recipient minor eligible members and outlines the administration**  
12       **of and payment from these accounts (Section III.D.1 and III.D.2 of the 2020**  
13       **Tohono O'odham Nation Non-Gaming Per Capita Plan); and**

14       **WHEREAS, the Trust Agreement with Principal Trust Company requires that a listing of all**  
15       **minor beneficiaries turning 18 and identified in the Monthly Age 18 Report for**  
16       **January 2026 be presented to the Tohono O'odham Legislative Council to obtain**  
17       **approval to distribute the trust funds to eligible minor members as they are no**  
18       **longer restricted beneficiaries; and**

19       **WHEREAS, the Enrollment Office has determined that the minors identified on the Monthly**  
20       **Age 18 Report for January 2026 reached, or will reach the age of 18 during the**  
21       **month of January 2026, and are no longer restricted from receiving their per**  
22       **capita payments; and**

23       **WHEREAS, the Enrollment Office has verified that the beneficiaries on the Monthly Age 18**  
24       **Report for January 2026 are also listed on the applicable master minor listing**  
25       **approved by Legislative Council resolution.**

26       **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
27       **Monthly Age 18 Report for January 2026 and authorizes Principal Trust Company**  
28       **to commence payment to the non-restricted beneficiaries listed on the Monthly**  
29       **Age 18 Report for January 2026, subject to the additional requirements of the**  
30       **Trust Agreement and written confirmation of the beneficiary's current mailing**  
31       **address and other information.**

15 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
16 18, 1934 (48 Stat.984).**


