

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2026 Schuk Toak District Sil Nakya Community Budget  
Amendment No. 1)**

**RESOLUTION NO. 26-025**

1   **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**  
2   **Nation,**

3   **No district council shall expend district funds except pursuant to budgets**  
4   **authorized under resolutions of the district council and approved by the**  
5   **Tohono O'odham Council. The management of these funds shall be only by**  
6   **a treasurer or other authorized officer of the district council who has**  
7   **furnished a surety bond satisfactory to the treasurer of the Tohono O'odham**  
8   **Nation, and all expenditures of these funds shall be by checks signed by such**  
9   **treasurer or other authorized officer and the chairman or vice chairman of**  
10   **the district council.**

12   **WHEREAS, the FY 2026 Schuk Toak District Budget in the amount of \$8,859,278.52 was**  
13   **authorized by Schuk Toak District Council Resolution No. ST-08-21-25-094 and**  
14   **approved by Legislative Council Resolution No. 25-340; and**

15   **WHEREAS, by Schuk Toak District Council Resolution No. ST-12-13-25-133, the Schuk Toak**  
16   **District Council has authorized and submitted for review and approval its FY 2026**  
17   **Schuk Toak District Sil Nakya Community Budget Amendment No. 1, which is**  
18   **incorporated by this reference and which will adjust operational and/or**  
19   **personnel line items; and**

20   **WHEREAS, the FY 2026 Schuk Toak District Sil Nakya Community Budget Amendment No. 1**  
21   **will not change the FY 2026 Schuk Toak District Sil Nakya Community Budget**  
22   **amount of \$239,728.75 nor will it change the FY 2026 Schuk Toak District Budget**  
23   **amount of \$8,859,278.52; and**

24   **WHEREAS, the Budget and Finance Committee has reviewed the FY 2026 Schuk Toak District**  
25   **Sil Nakya Community Budget Amendment No. 1 and recommends its approval.**

26   **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
27   **FY 2026 Schuk Toak District Sil Nakya Community Budget Amendment No. 1,**  
28   **effective October 1, 2025, which will not change the FY 2026 Schuk Toak District**  
29   **Sil Nakya Community Budget amount of \$239,728.75 nor will it change the FY 2026**  
30   **Schuk Toak District Budget amount of \$8,859,278.52.**



7 Tohono O'odham Nation and the Nation's laws, provided that any amendments or  
8 modifications shall be authorized under District Council resolution and  
9 submitted for prior approval by the Tohono O'odham Legislative Council.

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup>**  
11 **day of JANUARY 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0-**  
12 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
13 **Article IX, Section 7 the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
14 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
15 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**  
16 **(48 Stat.984).**






