

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2026 Baboquivari District Fresno Canyon Community Budget  
Amendment No. 2)**

**RESOLUTION NO. 26-043**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by  
6 a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2026 Baboquivari District Budget in the amount of \$5,373,205.73 was  
13 authorized by Baboquivari District Council Resolution No. 2025-B-79 and  
14 approved by Legislative Council Resolution No. 25-339, and subsequently  
15 amended by Legislative Council Resolution No. 25-424; and

16 **WHEREAS,** by Baboquivari District Council Resolution No. 2026-B-02, the Baboquivari  
17 District has authorized and submitted for review and approval its FY 2026  
18 Baboquivari District Fresno Canyon Community Budget Amendment No. 2,  
19 which is incorporated by this reference and which will adjust operational and/or  
20 personnel line items; and

21 **WHEREAS,** the FY 2026 Baboquivari District Fresno Canyon Community Budget Amendment  
22 No. 2 will not change the FY 2026 Baboquivari District Fresno Canyon Community  
23 Budget amount of \$612,040.19; and


24 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2026 Baboquivari District  
25 Fresno Canyon Community Budget Amendment No. 2 and recommends its  
26 approval.

27 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
28 FY 2026 Baboquivari District Fresno Canyon Community Budget Amendment No.  
29 2 effective October 1, 2025, which will not change the FY 2026 Baboquivari District  
30 Fresno Canyon Community Budget amount of \$612,040.19, nor will it affect the  
31 overall FY 2026 Baboquivari District Budget amount of \$5,451,425.35.


1 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2026  
2 Bahoquivari District Fresno Canyon Community Budget as amended shall be  
3 managed and expended in accordance with Article IX, Section 7 of the  
4 Constitution of the Tohono O'odham Nation and the Nation's laws, provided that  
5 any amendments or modifications shall be authorized under District Council  
6 resolution and submitted for prior approval by the Tohono O'odham Legislative  
7 Council.

8 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>  
9 day of FEBRUARY 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR;  
10 -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
11 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
12 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
13 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934  
14 (48 Stat.984).






