

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 Sif-Oidak District ARPA Budget Amendment No. 2 to
Extend Budget Period)**

RESOLUTION NO. 26-060

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2021-2024 Sif-Oidak District American Rescue Plan Act ("ARPA") Budget in
13 the amount of \$3,148,897.00 was authorized by Sif-Oidak District Council
14 Resolution No. SODC 23-074 and approved by Legislative Council Resolution No.
15 23-324 and subsequently amended by Legislative Council Resolution No. 24 058;
16 and

17 **WHEREAS,** by Sif-Oidak District Council Resolution No. SODC 26-011, the Sif-Oidak District
18 has authorized and submitted for review and approval its FY 2026 Sif Oidak
19 District ARPA Budget Amendment No. 2 in the amount of \$3,148,897.00, which is
20 incorporated by this reference, and which will extend the budget period; and

21 **WHEREAS,** the FY 2026 Sif Oidak District ARPA Budget Amendment No. 2 will not change the
22 original budget amount of \$3,148,897.00, but will extend the budget period to
23 October 1, 2024 through December 31, 2026; and

24 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2026 Sif-Oidak District
25 ARPA Budget Amendment No. 2 and recommends its approval.

26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
27 FY 2026 Sif-Oidak District ARPA Budget Amendment No. 2 in the amount of
28 \$3,148,897.00 effective October 1, 2024 through December 31, 2026.

29 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2026 Sif-Oidak
30 District American Rescue Plan Act Budget as amended shall be managed and
31 expended in accordance with Article IX, Section 7 of the Constitution of the
32 Tohono O'odham Nation and the Nation's laws, provided that any amendments or




1 modifications shall be authorized under District Council resolution and
2 submitted for prior approval by the Tohono O'odham Legislative Council.

3 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH
4 day of FEBRUARY 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR;
5 -0- AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by
6 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
7 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
8 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
9 (48 Stat.984).






