

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Recognition of Relinquishment from membership in the Tohono O'odham
Nation for the month of MARCH 2026)**

RESOLUTION NO. 26-077

1 **WHEREAS,** Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests the
2 Tohono O'odham Legislative Council with the power to "enact laws and
3 ordinances governing the enrollment and adoption of members and the
4 relinquishment and loss of membership"; and

5 **WHEREAS,** in accordance with the Tohono O'odham Nation's Enrollment Ordinance,
6 Ordinance No. 05-81 as amended the Enrollment Committee has received a
7 written statement from 02 trihal members whom have expressed their intent to
8 relinquish their membership with the Tohono O'odham Nation and the members
9 are identified in the March 2026 Relinquishment List, which is incorporated by
10 this reference; and

11 **WHEREAS,** pursuant to Article IX Section 1 of the Enrollment Ordinance,

13 **A member of the Nation may relinquish his membership in the**
14 **Nation by submitting a written statement clearly expressing an**
15 **intent to relinquish his membership to the Council, a copy of**
16 **which must be served on the committee. The written statement**
17 **must be signed by the person wishing to relinquish his membership**
18 **or, if a minor or incompetent, by the parent(s), guardian or other**
19 **person legally authorized to act on his behalf. Relinquishment**
20 **does not require the approval of the Council, but is effective upon**
21 **receipt of the statement by the Council and cannot be subsequently**
22 **denied. Upon recognition by the Council that the individual has**
23 **renounced his membership, his name shall be deleted from the**
24 **membership roll.**

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council hereby
26 recognizes that the two individuals identified in the March 2026 Relinquishment
27 List have relinquished their membership in the Tohono O'odham Nation and
28 orders the removal of their name from the Nation's membership roll.


