

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Professional Services Agreement Between the Tohono  
O'odham Nation and Human Resource Training, Inc. DBA Clarvida 2)**

**RESOLUTION NO. 26-089**

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to "consult,  
2 negotiate and conclude agreements . . . on behalf of the Tohono O'odham Nation  
3 with Federal, State and local governments . . . or their departments, agencies, or  
4 political subdivisions, or with private persons or organizations on all matters  
5 within the authority of the Tohono O'odham Council"; to "promote, protect and  
6 provide for public health, peace, morals, education and general welfare of the  
7 Tohono O'odham Nation and its members"; "to manage any funds within the  
8 exclusive control of the Tohono O'odham Nation . . . and to appropriate these  
9 funds for the benefit of the Nation and its members"; and "to adopt, approve and  
10 amend annual budgets and to authorize the expenditure of funds in accordance  
11 with these budgets" (Constitution of the Tohono O'odham Nation, Article VI,  
12 Sections 1(f), 1(c)(2), 1(d)(2) and 1(d)(3)); and

13 **WHEREAS,** the Tohono O'odham Nation has negotiated a new Professional Services  
14 Agreement Between the Tohono O'odham Nation and Human Resource Training,  
15 Inc. DBA Clarvida 2, in an amount not to exceed \$2,000,000.00 which will allow  
16 Human Resource Training, Inc. DBA Clarvida 2 to provide residential and foster  
17 care services for the Nation's minor children under the custody of the Nation's  
18 Health and Human Services Department Child Welfare Services Division; and

19 **WHEREAS,** the budget for the Professional Services Agreement Between the Tohono  
20 O'odham Nation and Human Resource Training, Inc. DBA Clarvida 2 exceeds  
21 \$500,000; and

22 **WHEREAS,** the funding for the Professional Services Agreement Between the Tohono  
23 O'odham Nation and Human Resource Training, Inc. DBA Clarvida 2 will come  
24 from the FY 2026 Department of Health and Human Services Division of Child  
25 Welfare Services Tribal Child Welfare Budget 001-26-6051; and

26 **WHEREAS,** the Health and Human Services Committee has reviewed the Professional  
27 Services Agreement Between the Tohono O'odham Nation and Human Resource  
28 Training, Inc. DBA Clarvida 2 and recommends its approval.

29 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
30 Professional Services Agreement Between the Tohono O'odham Nation and  
31 Human Resource Training, Inc. DBA Clarvida 2.



3 **Professional Services Agreement Between the Tohono O'odham Nation and**  
4 **Human Resource Training, Inc. DBA Clarvida 2** substantially in the form attached  
5 **hereto** provided that any amendments shall be submitted for prior approval by  
6 **the Tohono O'odham Legislative Council.**

7 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup>**  
8 **day of MARCH 2026** at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0-  
9 **AGAINST; -0- NOT VOTING; and [03] ABSENT,** pursuant to the powers vested in the Council by  
10 **Article VI, Section 1(c)(2), (d)(2), (d)(3) and (f) of the Constitution of the Tohono O'odham Nation,**  
11 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
12 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
13 **Act of June 18, 1934 (48 Stat.984).**


