

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022-2027 Sells District American Rescue Plan Act Budget Amendment No. 2)

RESOLUTION NO. 26-091

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

4 **No district council shall expend district funds except pursuant to budgets**
5 **authorized under resolutions of the district council and approved by the**
6 **Tohono O'odham Council. The management of these funds shall be only by**
7 **a treasurer or other authorized officer of the district council who has**
8 **furnished a surety bond satisfactory to the treasurer of the Tohono**
9 **O'odham Nation, and all expenditures of these funds shall be by checks**
10 **signed by such treasurer or other authorized officer and the chairman or**
11 **vice chairman of the district council.**

14 **WHEREAS,** the FY 2022-2024 Sells District American Rescue Plan Act Budget in the amount of
15 \$7,135,021.00 was authorized by Sells District Council Resolution No. SD-67-23
16 and approved by Legislative Council Resolution No. 23-196 and subsequently
17 amended by Legislative Council Resolution No. 24-432; and

18 **WHEREAS,** by Sells District Council Resolution No. SD-07-26, the Sells District has authorized
19 and submitted for review and approval its FY 2022-2027 Sells District American
20 Rescue Plan Act Budget Amendment No. 2, which is incorporated by this
21 reference, and which will adjust operational and/or personnel line items; and

22 **WHEREAS,** the FY 2022-2027 Sells District American Rescue Plan Act Budget Amendment No.
23 2 will not change the original budget amount of \$7,135,021.00; and

24 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2022-2027 Sells District
25 American Rescue Plan Act Budget Amendment No. 2 and recommend its
26 approval.

27 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
28 FY 2022-2027 Sells District American Rescue Plan Act Budget Amendment No. 2,
29 effective October 1, 2021 and ending December 31, 2026, which will not change
30 the original budget amount of \$7,135,021.00.

31 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2022-2027 Sells
32 District American Rescue Plan Act Budget as amended shall be managed and
33 expended in accordance with Article IX, Section 7 of the Constitution of the

Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH day of MARCH 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
