

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Professional Services Agreement Between the Tohono
O'odham Nation and Skyline Builders and Restoration, Inc.)**

RESOLUTION NO. 26-100

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power "[t]o consult,
2 negotiate and conclude agreements . . . on behalf of the Tohono O'odham Nation
3 with Federal, State and local governments . . . or with private persons or
4 organizations on all matters within the authority of the Tohono O'odham
5 Council" and "[t]o exercise the inherent powers of the Tohono O'odham Nation by
6 providing . . . resolutions . . . to promote, protect and provide for public health,
7 peace, morals, education and general welfare of the Tohono O'odham Nation and
8 its members" (Constitution of the Tohono O'odham Nation, Article VI, Section I(f)
9 and Article VI, Section 1(c)(2)); and

10 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the authority to approve,
11 by legislative action "...contracts and agreements with a total value in excess of
12 \$500,000.00" (Tohono O'odham Code, Title 26, Chapter 1, Article 4, Section
13 1402(F)); and

14 **WHEREAS,** the Nation's Department of Corrections Correctional Facility is in need of
15 renovations and has identified Skyline Builders and Restoration, Inc. to complete
16 the renovations, whose Professional Services Agreement in the amount of
17 \$732,691.04 is incorporated by this reference; and

18 **WHEREAS,** the Domestic Affairs Committee has reviewed the Professional Services
19 Agreement Between the Tohono O'odham Nation and Skyline Builders and
20 Restoration, Inc. and recommends its approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
22 Professional Services Agreement Between the Tohono O'odham Nation and
23 Skyline Builders and Restoration, Inc.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 Nation Chairperson or any designated official is authorized to execute the
26 Professional Services Agreement Between the Tohono O'odham Nation and
27 Skyline Builders and Restoration, Inc substantially in the form attached hereto
28 provided that any amendments shall be submitted for prior approval by the
29 Tohono O'odham Legislative Council.
