

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025-2026 Pisinemo District Pisinemo Community
Mining Royalty Multi Year Budget Amendment No. 1)**

RESOLUTION NO. 26-102

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2025-2026 Pisinemo District Pisinemo Community Mining Royalty Multi
13 Year Budget in the amount of \$48,883.28 was authorized by Pisinemo District
14 Council Resolution No. 25-P-35 and approved by Legislative Council Resolution
15 No. 25-224; and

16 **WHEREAS,** by Pisinemo District Council Resolution No. 26-P-27, the Pisinemo District has
17 authorized and submitted for review and approval its FY 2025-2026 Pisinemo
18 Community Mining Royalty Multi-Year Budget Amendment No. 1, which is
19 incorporated by this reference and which will adjust operational and/or
20 personnel line items; and

21 **WHEREAS,** the FY 2025-2026 Pisinemo District Pisinemo Community Mining Royalty Multi
22 Year Budget Amendment No. 1 will increase the FY 2025-2026 Pisinemo District
23 Pisinemo Community Mining Royalty Multi-Year Budget by \$40,846.06 from
24 \$48,883.28 to \$89,729.34; and

25 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2025-2026 Pisinemo
26 District Pisinemo Community Mining Royalty Multi-Year Budget Amendment No.
27 1 and recommends its approval.

28 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
29 FY 2025-2026 Pisinemo District Pisinemo Community Mining Royalty Multi-Year
30 Budget Amendment No. 1 effective October 1, 2024, which includes a \$40,846.06
31 increase from \$48,883.28 to \$89,729.34 that shall be funded by FY 2025 district
32 mining royalties allocation funds.

5 **provided that any amendments or modifications shall be authorized under**
6 **District Council resolution and submitted for prior approval by the Tohono**
7 **O'odham Legislative Council.**


8 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07th**

11 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
12 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
13 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**




