

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 - FY 2027 Executive Branch American Rescue Plan Act
Budget Amendment No. 3)**


RESOLUTION NO. 26-108

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and
7 **WHEREAS,** the Tohono O'odham Nation ("Nation") received funding from the United States
8 American Rescue Plan Act ("Recovery Funds") established by the American
9 Rescue Plan Act of 2021 ("ARP Act"); and
10 **WHEREAS,** the FY 2022 Executive Branch American Rescue Plan Act Budget in the amount of
11 \$170,056,409.00 was approved by Resolution No. 22-077 and subsequently
12 amended by Resolution No. 22-397 in the amount of \$163,072,609.00; and
13 **WHEREAS,** the FY 2025 - FY 2027 Executive Branch American Rescue Plan Act Budget
14 Amendment 2 in the amount of \$157,153,804.10 was approved by Resolution No.
15 24-399; and
16 **WHEREAS,** the Executive Branch has prepared and submitted for review and approval its FY
17 2026 - FY 2027 American Rescue Plan Act Budget Amendment No. 3, which is
18 incorporated by this reference and which will adjust operational line items; and
19 **WHEREAS,** the FY 2026 - FY 2027 American Rescue Plan Act Budget Amendment No. 3 will not
20 change the total budget of \$157,153,804.10; and
21 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2026 - FY 2027 Executive
22 Branch American Rescue Plan Act Budget Amendment No. 3 and recommend its
23 approval.
24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
25 FY 2026 - FY 2027 Executive Branch American Rescue Plan Act Budget Amendment
26 No. 3 effective March 11, 2021 ending December 31, 2026, in the amount of
27 \$157,153,804.10, which shall be funded by the American Rescue Plan Recovery
28 Fund.
29 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
30 Nation chairperson or any designated official is authorized to administer and
31 expend the FY 2026 - FY 2027 Executive Branch American Rescue Plan Act Budget

as amended, provided that any amendments or modifications shall be submitted
for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH
day of APRIL 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0-
AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by
Article VI, Section 1(c)(1) and Section 2(d) of the Constitution of the Tohono O'odham Nation,
adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
Act of June 18, 1934 (48 Stat.984).


