

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a Purchase and Sale Agreement for Long Term Storage Credits
Between the Tohono O'odham Nation and the Central Arizona
Water Conservation District)**

RESOLUTION NO. 26-111

1 **WHEREAS,** the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2 the power "[t]o consult, negotiate and conclude agreements and contracts on
3 behalf of the Tohono O'odham Nation with Federal, State and local governments
4 and other Indian tribes or their departments, agencies or political subdivisions,
5 or with private persons or organizations on all matters within the authority of the
6 Tohono O'odham Council." (Constitution of the Tohono O'odham Nation, Article
7 VI, Section 1(f)); and

8 **WHEREAS,** the Constitution of the Tohono O'odham Nation further vests the Legislative
9 Council with the power to "[e]nter into agreements, compacts or other contracts
10 for the beneficial use, sale, or lease or distribution" of "[a]ll waters which
11 originate in or flow in, into, or through the Tohono O'odham Nation"
12 (Constitution of the Tohono O'odham Nation, Article XVII, Section 1 and Section
13 2(b)); and

14 **WHEREAS,** by Resolution No. 19-372, the Legislative Council approved the Tohono O'odham
15 Nation Long-Term Storage Credit Marketing Plan authorizing Headwaters
16 Consulting, LLC to market long-term storage credits held by the Nation; and

17 **WHEREAS,** Headwaters Consulting, LLC has negotiated a Purchase and Sale Agreement for
18 Long Term Storage Credits between the Tohono O'odham Nation and the Central
19 Arizona Water Conservation District (CAWCD) which is incorporated herein by
20 this reference; and

21 **WHEREAS,** the Professional Service Agreement with Headwaters Consulting, LLC provides
22 that a Transaction Success Fee be paid out of the gross proceeds of the sales
23 transaction; and

24 **WHEREAS,** the Water Resources Committee has reviewed the Purchase and Sale Agreement
25 for Long Term Storage Credits between the Tohono O'odham Nation and CAWCD
26 and recommends its approval.

27 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
28 Purchase and Sale Agreement for Long Term Storage Credits between the Tohono
29 O'odham Nation and CAWCD and authorizes the Nation's chairperson to execute
30 a formal legal agreement memorializing these terms.


1 **BE IT FURTHER RESOLVED** that the Legislative Council authorizes the limited waiver of
2 **sovereign immunity included in the Purchase and Sale Agreement.**

3 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that funds generated by
4 **this sale will be deposited into the Water Revenue Account established by**
5 **Resolution No. 14-525.**

6 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that funds for payment of
7 **the Headwaters Consulting, LLC Transaction Success Fee shall be appropriated**
8 **from the Water Revenue Account established by Resolution No. 14- 525.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
10 **day of APRIL 2026 at a meeting at which a quorum was present with a vote of 2,505.6 FOR; -0-**
11 **AGAINST; 565.7 [02] NOT VOTING; and 249.8[06] ABSENT, pursuant to the powers vested in the**
12 **Council by Article VI, Section 1(f) and Article XVII, Section 1 and 2 (b) of the Constitution of the**
13 **Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and**
14 **approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**
15 **1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**




