

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 Hewel Ni'ok KOHN Corporation for Public Broadcasting
Community Service Grant Restricted Budget Amendment No. 1)**

RESOLUTION NO. 26-117

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2026 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community
8 Service Grant Restricted Budget in the amount of \$96,174.54 was approved by
9 Resolution No. 25-311; and

10 **WHEREAS,** the Hewel Ni'ok has prepared and submitted for review and approval its FY 2026
11 KOHN Corporation for Public Broadcasting Community Service Grant Restricted
12 Budget Amendment No. 1 which is incorporated by this reference, and which will
13 adjust personnel and operational line items; and

14 **WHEREAS,** the FY 2026 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community
15 Service Grant Restricted Budget Amendment No. 1 will decrease the FY 2026
16 KOHN Corporation for Public Broadcasting Community Service Grant Restricted
17 Budget by \$48,700.47, from \$96,174.54 to \$47,474.07; and

18 **WHEREAS,** the Cultural Preservation and Budget and Finance Committees have reviewed the
19 FY 2026 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community
20 Service Grant Restricted Budget Amendment No. 1 and recommend its approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
22 FY 2026 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community
23 Service Grant Restricted Budget Amendment No. 1, effective October 1, 2025,
24 through September 30, 2026 which includes a \$48,700.47 decrease from
25 \$96,174.54 to \$47,474.07 that shall be funded by the Nation's general fund pending
26 reimbursement by the grantor, the Corporation for Public Broadcasting.

27 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
28 Nation chairperson or any designated official is authorized to administer and
29 expend the FY 2026 Hewel Ni'ok KOHN Corporation for Public Broadcasting
30 Community Service Grant Restricted Budget as amended, provided that any
31 amendments or modifications shall be submitted for prior approval by the
32 Tohono O'odham Legislative Council.
