

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 1 (Modification) to Design-Build Agreement
Between the Tohono O'odham Nation and AXIOS Builders, LLC)**

RESOLUTION NO. 26-121

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power "[t]o consult,
2 negotiate and conclude agreements and contracts on behalf of the Tohono
3 O'odham Nation . . . with private persons or organizations on all matters within
4 the authority of the Tohono O'odham Council"; "to manage any funds within the
5 exclusive control of the Tohono O'odham Nation . . . and to appropriate these
6 funds for the benefit of the nation and its members" provided that "[a]ll
7 expenditures of these funds shall be pursuant to appropriations or budgets
8 authorized under resolutions or in accordance with ordinances of the Tohono
9 O'odham Council"; and to provide resolutions "to promote, protect and provide
10 for public health, peace, morals, education and general welfare of the Tohono
11 O'odham Nation and its members" (Constitution of the Tohono O'odham Nation,
12 Article VI, Sections 1(f), d(2) and (c)(2); and

13 **WHEREAS,** by Resolution No. 24-430, the Tohono O'odham Legislative Council approved the
14 design-build agreement between the Tohono O'odham Nation and AXIOS
15 Builders, LLC, which provides that AXIOS Builders, LLC shall be compensated in
16 the amount of and not to exceed \$5,940,000.00; and

17 **WHEREAS,** the Tohono O'odham Nation Department of Public Safety wishes to amend the
18 compensation amount of the design-build agreement from \$5,940,000.00 to
19 \$6,935,025.28, an increase of \$995,025.28, due to revisions to the project scope
20 and budget based on the updated Tohono O'odham Westside Fire & Police
21 Substation budget for FY2026; and

22 **WHEREAS,** the additional compensation amount of \$995,025.28 is to be funded by the FY2022
23 Executive Branch American Rescue Plan Act Budget approved by Resolution No.
24 22-077 and amended by Resolution Nos. 22-397 and 24-399; and

25 **WHEREAS,** the Domestic Affairs Committee has reviewed the Amendment No. 1
26 (Modification) to Design-Build Agreement Between the Tohono O'odham Nation
27 and AXIOS Builders, LLC and recommends its approval.

28 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
29 Amendment No. 1 (Modification) to Design-Build Agreement Between the Tohono
30 O'odham Nation and AXIOS Builders, LLC.

1 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the additional
2 compensation amount of \$995,025.28 shall be funded by the FY2022 Executive
3 Branch American Rescue Plan Act Budget approved by Resolution No. 22-077 and
4 amended by Resolution Nos. 22-397 and 24-399.

5 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
6 Nation chairperson or any designated official is authorized to execute the
7 Amendment No. 1 (Modification) to Design-Build Agreement Between the Tohono
8 O'odham Nation and AXIOS Builders, LLC substantially in the form attached
9 hereto provided that any amendments shall be submitted for prior approval by
10 the Tohono O'odham Legislative Council.

11 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH
12 day of APRIL 2026 at a meeting at which a quorum was present with a vote of 2,959.2 FOR; -0-
13 AGAINST; -0- NOT VOTING; and 361.9 [04] ABSENT, pursuant to the powers vested in the Council
14 by Article VI, Sections 1(c)(2), d(2), and (f) of the Constitution of the Tohono O'odham Nation,
15 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
16 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
17 Act of June 18, 1934 (48 Stat.984).


