

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025-2026 Schuk Toak District American Rescue Plan
Act Budget Amendment No. 2)**

RESOLUTION NO. 26-126

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2021-2025 Schuk Toak District American Rescue Plan Act Budget in the
13 amount of \$2,442,446.00 was authorized by Schuk Toak District Council
14 Resolution No. ST-11-10-22-110 and approved by Legislative Council Resolution
15 No. 23-274 and subsequently amended by Resolution No. 24-431; and

16 **WHEREAS,** by Schuk Toak District Council Resolution No. ST-02-14-26-022, the Schuk Toak
17 District Council has authorized and submitted for review and approval its FY
18 2025-2026 Schuk Toak District American Rescue Plan Act Budget Amendment No.
19 2, which is incorporated by the reference, and which will adjust operational line
20 items; and

21 **WHEREAS,** the FY 2025-2026 Schuk Toak District American Rescue Plan Act Budget
22 Amendment No. 2 will not change the original budget amount of \$2,442,446.00;
23 and


24 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2025-2026 Schuk Toak
25 District American Rescue Plan Act Budget Amendment No. 2 and recommends its
26 approval.

27 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
28 FY 2025-2026 Schuk Toak District American Rescue Plan Act Budget Amendment
29 No. 2 in the amount of \$2,442,446.00, effective March 11, 2021 and ending
30 December 31, 2026, and which will not change the original budget amount of
31 \$2,442,446.00.

1 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2025-2026
 2 **Schuk Toak District American Rescue Plan Act Budget as amended shall be**
 3 **managed and expended in accordance with Article IX, Section 7 of the**
 4 **Constitution of the Tohono O'odham Nation and the Nation's laws, provided that**
 5 **any amendments or modifications shall be authorized under District Council**
 6 **resolution and submitted for prior approval by the Tohono O'odham Legislative**
 7 **Council.**

8 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
 9 **day of APRIL 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0-**
 10 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
 11 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
 12 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
 13 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
 14 **(48 Stat.984).**




