RESOLUTION NO. 26-129

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members**
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Articles VI and VII of the Nation's Enrollment Ordinance, the**
6 **Enrollment Committee shall review membership applications and make a**
7 **written recommendation to the Tohono O'odham Legislative Council to approve**
8 **or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment**
9 **Ordinance); and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**
11 **O'odham Legislative Council shall determine eligibility for membership or**
12 **adoption; and**

13 **WHEREAS, the Enrollment Program has received official documents reflecting the legal**
14 **name changes of enrolled members as a result of marriage, divorce, legal**
15 **adoption, or for other reasons; and**

16 **WHEREAS, the Enrollment Committee recommends that Resolution Nos. 32-80, 95-82, 83-83,**
17 **127-83, 184-83, 245-84, 92-124, 94-459, 95-082, 97-460, 98-123, 99-633, 06-328, 09-**
18 **101, 11-502, 14-394, 20-103, and 23-282 be amended to reflect the legal name**
19 **changes of members identified in the April 2026 Legal Enrollment Resolution**
20 **Summary, which is incorporated by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
22 **Nos. 32-80, 95-82, 83-83, 127-83, 184-83, 245-84, 92-124, 94-459, 95-082, 97-460, 98-**
23 **123, 99-633, 06-328, 09-101, 11-502, 14-394, 20-103, and 23-282 are amended upon**
24 **the effective date of those resolutions to reflect the legal name changes of**
25 **members identified in the April 2026 Legal Enrollment Resolution Summary.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
27 **day of APRIL 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
29 **Article II, Sections 1 and 2; and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**
30 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
31 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
32 **16 of the Act of June 18, 1934 (48 Stat.984).**
