

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Non-Gaming Monthly Age 18 Report for April 2026 of Tohono
O'odham Eligible Minor Members and Authorizing Distribution of the
Per Capita Payments and Interest Held in Trust on Their Behalf
By Principal Trust Company)

RESOLUTION NO. 26-132

- 1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Tohono O'odham**
2 **Legislative Council with the power to "manage any funds within the exclusive**
3 **control of the Tohono O'odham Nation, including proceeds derived from lands**
4 **and resources of the Tohono O'odham Nation, and to appropriate these funds for**
5 **the benefit of the nation and its members" (Constitution, Article VI, Section**
6 **1(d)(2)); and**
- 7 **WHEREAS, the 2020 Tohono O'odham Nation Non-Gaming Per Capita Plan was adopted by**
8 **Legislative Council Resolution No. 20-070 to govern a one-time non-gaming**
9 **revenue per capita distribution to eligible members of the Tohono O'odham**
10 **Nation; and**
- 11 **WHEREAS, by Resolution No. 20-291, the Legislative Council approved the Master List for the**
12 **2020 Non-Gaming Per Capita Distribution for Minor Tohono O'odham Members**
13 **for use by Membership Services in the administration of the 2020 Non-Gaming**
14 **Per Capita Distribution; and**
- 15 **WHEREAS, disbursement of the 2020 Non-Gaming Per Capita payment to each eligible minor**
16 **Tohono O'odham member is contingent upon certification of the member's**
17 **eligibility and compliance with the Trust Agreement with Principal Trust**
18 **Company for the benefit of minor eligible members, which establishes interest -**
19 **bearing accounts on behalf of the recipient minor eligible members and outlines**
20 **the administration of and payment from these accounts (Section III.D.1 and**
21 **III.D.2 of the 2020 Tohono O'odham Nation Non-Gaming Per Capita Plan); and**
- 22 **WHEREAS, the Trust Agreement with Principal Trust Company requires that a listing of all**
23 **minor beneficiaries turning 18, as identified in the Non-Gaming Monthly Age 18**
24 **Report for April 2026, be presented to the Tohono O'odham Legislative Council to**
25 **obtain approval to distribute the trust funds to eligible minor members as they**
26 **are no longer restricted beneficiaries; and**
- 27 **WHEREAS, the Enrollment Office has determined that the minors identified on the Non-**
28 **Gaming Monthly Age 18 Report for April 2026 reached, or will reach the age of 18**
29 **during the month of April 2026, and are no longer restricted from receiving their**
30 **per capita payments; and**



1 **WHEREAS, the Enrollment Office has verified that the beneficiaries on the Non-Gaming**
2 **Monthly Age 18 Report for April 2026 are also listed on the applicable master**
3 **minor listing approved by Legislative Council resolution.**

4 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
5 **Monthly Age 18 Report for April 2026, attached and incorporated by this**
6 **reference, and authorizes Principal Trust Company to commence payment to the**
7 **non-restricted beneficiaries listed on the Non-Gaming Monthly Age 18 Report for**
8 **April 2026, subject to the additional requirements of the Trust Agreement and**
9 **written confirmation of the beneficiary's current mailing address and other**
10 **information.**

11 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
12 **day of APRIL 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0-**
13 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
14 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
15 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
16 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
17 **18, 1934 (48 Stat.984).**


