

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Certification of and Distribution to One Tohono O'odham Nation
Eligible Adult Member for the Fourth Per Capita Distribution for April 2026)**

RESOLUTION NO. 26-133

1 **WHEREAS,** on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the
2 "O'odham Voice on Use of Gaming Revenues" (the "Initiative"), which authorizes
3 per capita payments to the Nation's members provided that sufficient gaming
4 revenues are available; and

5 **WHEREAS,** the Ordinance for the Regulation of Gaming Activities Within the Tohono
6 O'odham Nation (the "Gaming Ordinance") was subsequently amended to
7 authorize per capita distribution payments in accordance with the Initiative
8 (Legislative Council Resolution No. 97-303); and

9 **WHEREAS,** by Resolution No. 09-164, the Legislative Council adopted the Tohono O'odham
10 Nation Revenue Allocation Plan; and

11 **WHEREAS,** on June 15, 2009, the Nation received notice from the Department of Interior that
12 the Tohono O'odham Nation Revenue Allocation Plan was approved; and

13 **WHEREAS,** the Tohono O'odham Nation Department of Membership Services submitted to
14 the Tohono O'odham Legislative Council the Master List for Eligible Adult Tohono
15 O'odham Members for the Fourth Per Capita Distribution ("Master List") for
16 review and approval; and

17 **WHEREAS,** by Resolution No. 09-428, Legislative Council approved the Master List with the
18 initial number of 19,141 verified adult members; and

19 **WHEREAS,** the disbursement of funds to each eligible adult member is contingent upon
20 verification of a member and certification by the Tohono O'odham Legislative
21 Council; and

22 **WHEREAS,** the Tohono O'odham Department of Membership Services has submitted a
23 certification list of one verified adult member who is listed on the previously
24 approved Master List and is eligible to receive the fourth per capita payment; and

25 **WHEREAS,** the Rules Committee has reviewed the certification list and recommends
26 approval.

27 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council hereby:

- 28 1. Approves the verification and certification of one adult member listed on
29 the attached April 2026 Certification Listing of Adult Members for the
30 Fourth Per Capita Distribution.
- 31 2. Approves the distribution of \$2,000, less any applicable taxes required by
32 federal law, to the adult member listed.


