

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2026 Department of Health and Human Services, Division of Family Assistance Elderly and Low-Income Subsidy Assistance Program Budget Amendment No. 1)

RESOLUTION NO. 26-135

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2026 Department of Health and Human Services, Division of Family**
8 **Assistance Elderly and Low-Income Subsidy Assistance Program Budget in the**
9 **amount of \$1,484,500.46 was approved by Resolution No. 25-450; and**

10 **WHEREAS, the Department of Health and Human Services, Division of Family Assistance**
11 **Elderly and Low-Income Subsidy Assistance Program has prepared and**
12 **submitted for review and approval its FY 2026 Budget Amendment No. 1, which is**
13 **incorporated by this reference, and which will adjust personnel and operational**
14 **line items; and**

15 **WHEREAS, the FY 2026 Department of Health and Human Services, Division of Family**
16 **Assistance Elderly and Low-Income Subsidy Assistance Program Budget**
17 **Amendment No. 1 will not cause any change to the \$1,484,500.46 budget amount;**
18 **and**

19 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
20 **reviewed the FY 2026 Department of Health and Human Services, Division of**
21 **Family Assistance Elderly and Low-Income Subsidy Assistance Program Budget**
22 **Amendment No. 1 and recommend its approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
24 **FY 2026 Department of Health and Human Services, Division of Family Assistance**
25 **Elderly and Low-Income Subsidy Assistance Program Budget Amendment No.1**
26 **effective October 1, 2025, which does not cause a change in the budget amount of**
27 **\$1,484,500.46 that shall be funded by the Nation's general fund.**

28 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
29 **Nation chairperson or any designated official is authorized to administer and**
30 **expend the FY 2026 Department of Health and Human Services, Division of Family**
31 **Assistance Elderly and Low-Income Subsidy Assistance Program Budget as**

amended, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH day of APRIL 2026 at a meeting at which a quorum was present with a vote of 3,321,1 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
