

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 Planning and Economic Development Department Roads
Program PIR 10(1) Fresno Canyon Wash Bridge No. 662 Budget Amendment No. 2)**

RESOLUTION NO. 26-151

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2022 Planning and Economic Development Department Roads Program
8 PIR10(1) Fresno Canyon Wash Bridge No. 662 Budget in the amount of \$90,000.00
9 was approved by Resolution No. 21-431; and

10 **WHEREAS,** the FY 2022 Planning and Economic Development Department Roads Program
11 PIR 10(1) Fresno Canyon Wash Bridge No. 662 Budget Amendment No. 1 in the
12 amount of \$290,000.00 was approved by Resolution No. 22-434 for a budget term
13 of October 1, 2021 through September 30, 2024; and

14 **WHEREAS,** the U.S. Bureau of Indian Affairs ("BIA") has granted a No Cost Extension to extend
15 the project period to September 30, 2027; and

16 **WHEREAS,** the Planning and Economic Development Department, Roads Program has
17 prepared and submitted for review and approval its FY 2026 PIR 10(1) Fresno
18 Canyon Wash Bridge No. 662 Budget Amendment No. 2, which is incorporated by
19 this reference and which will not cause a change to the \$290,000.00 budget
20 amount; and

21 **WHEREAS,** the Agricultural and Natural Resources and Budget and Finance Committees
22 have reviewed the FY 2026 Planning and Economic Development Department
23 Roads Program PIR 10(1) Fresno Canyon Wash Bridge No. 662 Budget
24 Amendment No. 2 and recommend its approval.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council accepts the
26 No Cost Extension for the budget period to September 30, 2027 and approves the
27 FY 2026 Planning and Economic Development Department Roads Program PIR
28 10(1) Fresno Canyon Wash Bridge No. 662 Budget Amendment No. 2 effective
29 October 1, 2025 and ending September 30, 2027 in the amount of \$290,000.00,
30 which shall be funded by the Nation's general fund pending reimbursement from
31 the U.S. Bureau of Indian Affairs.



BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation chairperson or any designated official is authorized to administer and expend the FY 2026 Planning and Economic Development Department Roads Program PIR 10(1) Fresno Canyon Wash Bridge No. 662 Budget, as amended, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH day of MAY 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).






