

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Enrollment Resolution Nos. 23-82, 67-82, 150-82, 164-83, 186-84,  
389-89, 91-342, 98-123, 04-291, 08-606, 11-121, 12-425, 18-146, 25-070,  
and 25-289 to Reflect Legal Name Changes of Enrolled Members)**

**RESOLUTION NO. 26-157**

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws  
2 and ordinances governing the enrollment and adoption of members  
3 (Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and  
4 Article VI, Section 1(h)); and

5 **WHEREAS,** pursuant to Articles VI and VII of the Nation's Enrollment Ordinance, the  
6 Enrollment Committee shall review membership applications and make a  
7 written recommendation to the Tohono O'odham Legislative Council to approve  
8 or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment  
9 Ordinance); and

10 **WHEREAS,** pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono  
11 O'odham Legislative Council shall determine eligibility for membership or  
12 adoption; and

13 **WHEREAS,** the Enrollment Program has received official documents reflecting the legal  
14 name changes of enrolled members as a result of marriage, divorce, legal  
15 adoption, or for other reasons; and

16 **WHEREAS,** the Enrollment Committee recommends that Resolution Nos. 23-82, 67-82, 150-  
17 82, 164-83, 186-84, 389-89, 91-342, 98-123, 04-291, 08-606, 11-121, 12-425, 18-146,  
18 25-070, and 25-289 be amended to reflect the legal name changes of members  
19 identified in the May 2026 Legal Enrollment Resolution Summary, which is  
20 incorporated by this reference.

21 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution  
22 Nos. 23-82, 67-82, 150-82, 164-83, 186-84, 389-89, 91-342, 98-123, 04-291, 08-606,  
23 11-121, 12-425, 18-146, 25-070, and 25-289 are amended upon the effective date of  
24 those resolutions to reflect the legal name changes of members identified in the  
25 May 2026 Legal Enrollment Resolution Summary.

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>**  
27 **day of MAY 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**  
29 **Article II, Section 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**  
30 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
31 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
32 **16 of the Act of June 18, 1934 (48 Stat.984).**
