

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution Nos. 127-83, 334-88, 97-256, 04-109,
08-411, 08-456, 09-167, 09-330, 09-538, 09-575, 10-153, 10-225,
and 10-462 to Correct Names of Enrolled Members)**

RESOLUTION NO. 26-158

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws
2 and ordinances governing the enrollment and adoption of members
3 (Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and
4 Article VI, Section 1(h)); and

5 **WHEREAS,** pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the
6 Enrollment Committee shall review membership applications and make a
7 written recommendation to the Tohono O'odham Legislative Council to approve
8 or reject the applications (14 Tohono O'odham Code Chapter 1 – Enrollment
9 Ordinance); and

10 **WHEREAS,** pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono
11 O'odham Legislative Council shall determine eligibility for membership or
12 adoption; and

13 **WHEREAS,** the Enrollment Program has determined that a number of resolutions approving
14 membership and adoption applications misspelled or incorrectly listed the
15 names of members and/or incorrectly listed enrollment numbers; and

16 **WHEREAS,** the Enrollment Committee recommends that Resolution Nos. 127-83, 334-88, 97-
17 256, 04-109, 08-411, 08-456, 09-167, 09-330, 09-538, 09-575, 10-153, 10-225, and 10-
18 462 be amended to reflect the correct name for the members identified in the May
19 2026 Corrected Enrollment Resolution Summary, which is incorporated by this
20 reference.

21 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution
22 Nos. 127-83, 334-88, 97-256, 04-109, 08-411, 08-456, 09-167, 09-330, 09-538, 09-575,
23 10-153, 10-225, and 10-462 are amended upon the effective date of those
24 resolutions to reflect the correct names of members identified in the May 2026
25 Corrected Enrollment Resolution Summary.

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
27 **day of MAY 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
29 **Article II, Section 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**
30 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
31 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
32 **16 of the Act of June 18, 1934 (48 Stat.984).**
