

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
 (Approving FY 2026 Tohono O'odham Nation Health Care Budget Amendments
 for Casa Grande Clinic Third Party, Health Care Information Technologies
 Third Party, Health Care Security Third Party, General Medical Surgical
 Third Party, Pathology Medical Lab Third Party, PRC Fiscal
 Intermediary, Nursing Administration Program, Outpatient
 Department and Environmental Health)**

RESOLUTION NO. 26-162

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
 2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
 3 these funds for the benefit of the Nation and its members" provided that "[a]ll
 4 expenditures of these funds shall be pursuant to appropriations or budgets"
 5 authorized by resolution or ordinance; and "to adopt, approve and amend annual
 6 budgets and to authorize the expenditure of funds in accordance with these
 7 budgets" (Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2)
 8 and (3)); and

9 **WHEREAS,** the FY 2026 Tohono O'odham Nation Health Care ("TONHC") Budgets in the
 10 amount of \$150,226,850.07 were approved by Resolution No. 25-334; and

11 **WHEREAS,** the FY 2026 TONHC Budget Amendments decreased the previously approved
 12 budget amount by \$1,109,280.75 from \$150,226,850.07 to \$149,117,569.32, which
 13 was approved by Resolution No. 26-036; and

14 **WHEREAS,** TONHC has prepared and submitted for review and approval its FY 2026 Budget
 15 Amendments which will adjust operational and/or personnel line items; and

16 **WHEREAS,** the FY 2026 TONHC Budget Amendments will decrease the previously approved
 17 budget amount by \$2,249.17 from \$149,117,569.32 to \$149,115,320.15; and

18 **WHEREAS,** TONHC has prepared and submitted for review and approval these FY 2026
 19 TONHC Budget Amendments which identify the budget and its approved budget
 20 amount as well as the amended amount, as shown below and incorporated herein
 21 by reference:



14 Tobono O'odham Legislative Council.

15 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH
16 day of MAY 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0-
17 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
18 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
19 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
20 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
21 (48 Stat.984).






