

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026-2028 Schuk Toak District Multi-Year New Building
Project Construction Budget)**

RESOLUTION NO. 26-163

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

11 **; and**

12 **WHEREAS,** by Schuk Toak District Council Resolution No. ST-04-14-26-041, the Schuk Toak
13 **District has authorized the FY 2026-2028 Schuk Toak District Multi-Year New**
14 **Building Project Construction Budget, which is incorporated by this reference in**
15 **the amount of \$10,200,000.00; and**

16 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2026-2028 Schuk Toak
17 **District Multi-Year New Building Project Construction Budget and recommends**
18 **approval.**

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
20 **FY 2026-2028 Schuk Toak District Multi-Year New Building Project Construction**
21 **Budget effective October 1, 2025 in the amount of \$10,200,000.00, which shall be**
22 **funded as follows:**

- 23 **1. RBC Investment account in the amount of \$3,500,000.00; and**
- 24 **2. FY 2021-2025 Schuk Toak District Administration carry forward funds in the**
25 **amount of \$6,700,000.00.**

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2026-2028
27 **Schuk Toak District Multi-Year New Building Project Construction Budget shall**
28 **be managed and expended in accordance with Article IX, Section 7 of the**
29 **Constitution of the Tohono O'odham Nation and the Nation's laws, provided that**
30 **any amendments or modifications shall be authorized under District Council**
31 **resolution and submitted for prior approval by the Tohono O'odham Legislative**
32 **Council.**






