

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Enrollment or Adoption Applications for Membership in the
Tohono O'odham Nation for June 2026)**

RESOLUTION NO. 26-179

1 **WHEREAS,** Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests the
2 Tohono O'odham Legislative Council with the power to "enact laws and
3 ordinances governing the enrollment and adoption of members and the
4 relinquishment and loss of membership"; and

5 **WHEREAS,** in accordance with the Tohono O'odham Nation Enrollment Ordinance No. 05-81
6 as amended, the Enrollment Committee has reviewed and recommended
7 approval of the enrollment or adoption applications for the individuals
8 identified in the June 2026 Membership Applications List, which is incorporated
9 by this reference; and

10 **WHEREAS,** pursuant to Article VIII, Section 1 (C) (1) and (2) of the Enrollment Ordinance:

12 The final determination to approve or reject an application for membership
13 or adoption shall be recorded in a Council resolution. Each determination shall
14 set forth the following findings of fact:

15
16 (1) If an application for adoption is approved, the applicant's date of birth,
17 the degree of Papago-Tohono O'odham Indian Blood ascribed to the
18 applicant, and the Enrollment Committee's recommendation that the
19 application be approved or rejected;

21 (2) If an application for membership is approved, the applicant's date of
22 birth, the membership requirement which Council determined that the
23 applicant established, and the Enrollment Committee's recommendation
24 that the application be approved or rejected.

26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council has reviewed
27 the Enrollment Committee's recommendations and approves the applications
28 for enrollment or adoption that are identified in the June 2026 Membership
29 Applications List which includes the name, date of birth, enrollment number, and
30 membership requirement or, for adoption, the degree of Papago-Tohono
31 O'odham Indian blood for each applicant.
