1 **WHEREAS, the FY 2026 Chukut Kuk District West Villages Community Budget Amendment**
2 **No. 1 will increase the FY 2026 Chukut Kuk District West Villages Community**
3 **Budget by \$22,179.53 from \$40,000.00 to \$62,179.53; and**

4 **WHEREAS, by Chukut Kuk District Council Resolution No. 2026-03, the Chukut Kuk District**
5 **has authorized and submitted for review and approval the FY 2026 Chukut Kuk**
6 **District West Villages Community Mining Royalties Budget, which is**
7 **incorporated by this reference, in the amount of \$4,257.62; and**

8 **WHEREAS, the FY 2026 Chukut Kuk District Budget Amendment No. 2 will incorporate the FY**
9 **2026 San Miguel Community and West Villages Community Budget Amendments**
10 **No. 1 and will increase the FY 2026 Chukut Kuk District Budget by \$167,250.69**
11 **from \$3,009,126.73 to \$3,176,377.42; and**

12 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2026 Chukut Kuk District**
13 **San Miguel Community Budget Amendment No. 1, FY 2026 Chukut Kuk District**
14 **West Villages Community Budget Amendment No. 1, and FY 2026 Chukut Kuk**
15 **District West Villages Community Mining Royalties Budget and recommends**
16 **approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves:**

- 18 **1. FY 2026 Chukut Kuk District San Miguel Community Budget Amendment No.**
19 **1 effective October 1, 2025, which includes an increase of \$145,071.16 from**
20 **\$40,000.00 to \$185,071.16, and which shall be funded by:**
 - 21 **a. FY 2022 carryover funds in the amount of \$36,758.48;**
 - 22 **b. FY 2023 carryover funds in the amount of \$79,780.53;**
 - 23 **c. FY 2024 carryover funds in the amount of \$9,506.88; and**
 - 24 **d. FY 2025 carryover funds in the amount of \$19,025.27.**
- 25 **2. FY 2026 Chukut Kuk District West Villages Community Budget Amendment**
26 **No. 1 effective October 1, 2025, which includes an increase of \$22,179.53 from**
27 **\$40,000.00 to \$62,179.53, and which shall be funded by FY 2025 carryover**
28 **funds in the amount of \$22,179.53.**
- 29 **3. FY 2026 Chukut Kuk District West Villages Community Mining Royalties**
30 **Budget in the amount of \$4,257.62 shall be funded by:**
 - 31 **a. FY 2020 mining royalties in the amount of \$2,720.96; and**
 - 32 **b. FY 2023 mining royalties in the amount of \$1,536.66.**

4 **the amount of \$167,250.69**, and will increase the FY 2026 Chukut Kuk District
5 **Budget to \$3,176,377.42 from \$3,009,126.73.**

6 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2026 Chukut
7 **Kuk District Budget as amended shall be managed and expended in accordance**
8 **with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, and**
9 **the Nation's laws, provided that any amendments or modifications shall be**
10 **authorized under District Council resolution and submitted for prior approval by**
11 **the Tohono O'odham Legislative Council.**

12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD**
13 **day of JUNE 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0-**
14 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
15 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
16 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
17 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
18 **(48 Stat.984).**


