

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 Gu-Vo District Ali Chugk Community Budget Amendment No. 1)

RESOLUTION NO. 26-188

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2026 Gu-Vo District Budget in the amount of \$5,598,944.93 was authorized
13 by Gu-Vo District Council Resolution No. GV-25-075 and approved by Legislative
14 Council Resolution No. 25-342; and

15 **WHEREAS,** by Gu-Vo District Council Resolution No. GV-26-036, the Gu-Vo District has
16 authorized and submitted for review and approval its FY 2026 Gu-Vo District Ali
17 Chugk Community Budget Amendment No. 1, which is incorporated by this
18 reference and which will adjust operational and/or personnel line items; and

19 **WHEREAS,** the FY 2026 Gu-Vo District Ali Chugk Community Budget Amendment No. 1 will
20 not change the FY 2026 Gu-Vo District Ali Chugk Community Budget amount of
21 \$402,990.43; and

22 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2026 Gu-Vo District Ali
23 Chugk Community Budget Amendment No. 1 and recommends its approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
25 FY 2026 Gu-Vo District Ali Chugk Community Budget Amendment No. 1 effective
26 October 1, 2025, which will not change the FY 2026 Gu-Vo District Ali Chugk
27 Community Budget amount of \$402,990.43 nor will it change the overall FY 2026
28 Gu-Vo District Budget amount of \$5,598,944.93.

29 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2026 Gu-Vo
30 District Budget as amended shall be managed and expended in accordance with
31 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the
32 Nation's laws, provided that any amendments or modifications shall be

1 authorized under District Council resolution and submitted for prior approval by
2 the Tohono O'odham Legislative Council.

3 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH
4 day of JUNE 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0-
5 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
6 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
7 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
8 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
9 (48 Stat.984).


