

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing R. Marcos Ysmael to the Tohono O'odham Ki:Ki Association Board of Directors)**

RESOLUTION NO. 26-189

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "promote,**
2 **protect and provide for public health, peace, morals, education and general**
3 **welfare of the Tohono O'odham Nation and its members" and to "provide for,**
4 **appoint, or provide for the appointment of, and prescribe the duties and powers**
5 **of committees, boards, officers and agents" (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(c)(2) and Section 1(b)); and**

7 **WHEREAS, the Tohono O'odham Ki:ki Association ("TOKA") Board of Directors consists of five**
8 **voting members appointed by the Tohono O'odham Legislative Council who shall**
9 **serve staggered four year terms or until their successors are appointed, with no**
10 **more than two members' terms ending in a single year, and whose terms shall**
11 **commence on March 1 and end on the last day of February (18 Tohono O'odham**
12 **Code Chapter 1, Article V, Section 1.a.); and**

13 **WHEREAS, Board members shall have sufficient education and experience in housing,**
14 **construction, business, and finance to provide oversight of the TOKA in order to**
15 **achieve the TOKA's mission of providing safe, affordable, and well-constructed**
16 **housing (18 Tohono O'odham Code Chapter 1, Article V, Section 1(b)); and**

17 **WHEREAS, R. Marcos Ysmael was appointed to the TOKA Board of Directors by Resolution No.**
18 **22-097 for a term ending February 28, 2026 and he continues to serve until his**
19 **successor is appointed; and**

20 **WHEREAS, in accordance with the Board Appointment Guidelines, the Housing Committee**
21 **reviewed the TOKA Board of Directors candidate R. Marcos Ysmael's application**
22 **documents, his background investigation report, and interviewed him, and the**
23 **Rules Committee reviewed his application documents and background**
24 **investigation report; and**

25 **WHEREAS, the Housing Committee recommends the appointment of R. Marcos Ysmael, a**
26 **non-member with sufficient education and experience, to the TOKA Board of**
27 **Directors for a term beginning upon the effective date of this resolution and**
28 **ending February 28, 2030 or until his successor is appointed; and**

29 **WHEREAS, the Rules Committee also recommends the appointment of R. Marcos Ysmael to**
30 **the TOKA Board of Directors.**

31 **NOW, THEREFORE, BE IT RESOLVED that, notwithstanding Article V, Section 1.a. of 18 Tohono**
32 **O'odham Code Chapter 1, the Tohono O'odham Legislative Council appoints R.**
33 **Marcos Ysmael to the TOKA Board of Directors for a term beginning upon the**

effective date of this resolution and ending February 28, 2030 or until his
successor is appointed.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH
day of JUNE 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0-
AGAINST; [01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
Article VI, Section 1(b) and 1(c)(2) of the Constitution of the Tohono O'odham Nation, adopted by
the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
18, 1934 (48 Stat.984).
