

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Gregory O'Keefe to the Tohono O'odham Ki:Ki Association Board of Directors)**

RESOLUTION NO. 26-190

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "promote,**
2 **protect and provide for public health, peace, morals, education and general**
3 **welfare of the Tohono O'odham Nation and its members" and to "provide for,**
4 **appoint, or provide for the appointment of, and prescribe the duties and powers**
5 **of committees, boards, officers and agents" (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(c)(2) and Section 1(b)); and**

7 **WHEREAS, the Tohono O'odham Ki:ki Association ("TOKA") Board of Directors consists of five**
8 **voting members appointed by the Tohono O'odham Legislative Council who shall**
9 **serve staggered four year terms or until their successors are appointed, with no**
10 **more than two members' terms ending in a single year, and whose terms shall**
11 **commence on March 1 and end on the last day of February (18 Tohono O'odham**
12 **Code Chapter 1, Article V, Section 1.a.); and**

13 **WHEREAS, Board members shall have sufficient education and experience in housing,**
14 **construction, business, and finance to provide oversight of the TOKA in order to**
15 **achieve the TOKA's mission of providing safe, affordable, and well-constructed**
16 **housing (18 Tohono O'odham Code Chapter 1, Article V, Section 1(b)); and**

17 **WHEREAS, in accordance with the Board Appointment Guidelines, the Housing Committee**
18 **reviewed the TOKA Board of Directors candidate Gregory O'Keefe's application**
19 **documents, his background investigation report, and interviewed him, and the**
20 **Rules Committee reviewed his application documents and background**
21 **investigation report; and**

22 **WHEREAS, the Housing Committee recommends the appointment of Gregory O'Keefe, a non-**
23 **member with sufficient education and experience, to the TOKA Board of**
24 **Directors for a term beginning upon the effective date of this resolution and**
25 **ending February 29, 2028 or until his successor is appointed; and**

26 **WHEREAS, the Rules Committee also recommends the appointment of Gregory O'Keefe to**
27 **the TOKA Board of Directors.**

28 **NOW, THEREFORE, BE IT RESOLVED that, notwithstanding Article V, Section 1.a. of 18 Tohono**
29 **O'odham Code Chapter 1, the Tohono O'odham Legislative Council appoints**
30 **Gregory O'Keefe to the TOKA Board of Directors for a term beginning upon the**
31 **effective date of this resolution and ending February 29, 2028 or until his**
32 **successor is appointed.**
