

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 Gu-Vo District Administration Budget Amendment No. 1)**

RESOLUTION NO. 26-201

WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham Nation,

No district council shall expend district funds except pursuant to budgets authorized under resolutions of the district council and approved by the Tohono O'odham Council. The management of these funds shall be only by a treasurer or other authorized officer of the district council who has furnished a surety bond satisfactory to the treasurer of the Tohono O'odham Nation, and all expenditures of these funds shall be by checks signed by such treasurer or other authorized officer and the chairman or vice chairman of the district council.

; and

WHEREAS, the FY 2026 Gu-Vo District Budget in the amount of \$5,598,944.93 was authorized by Gu-Vo District Council Resolution No. GV-25-075 and approved by Legislative Council Resolution No. 25-342; and

WHEREAS, by Gu-Vo District Council Resolution No. GV-26-049, the Gu-Vo District has authorized and submitted for review and approval its FY 2026 Gu-Vo District Administration Budget Amendment No. 1, which is incorporated by this reference and which will adjust operational and/or personnel line items; and

WHEREAS, the FY 2026 Gu-Vo District Administration Budget Amendment No. 1 will not change the FY 2026 Gu-Vo District Administration Budget amount of \$3,986,983.21; and

WHEREAS, the Budget and Finance Committee has reviewed the FY 2026 Gu-Vo District Administration Budget Amendment No. 1 and recommends its approval.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the FY 2026 Gu-Vo District Administration Budget Amendment No. 1 effective October 1, 2025, which will not change the FY 2026 Gu-Vo District Administration Budget amount of \$3,986,983.21 nor will it change the overall FY 2026 Gu-Vo District Budget amount of \$5,598,944.93.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2026 Gu-Vo District Budget as amended shall be managed and expended in accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be

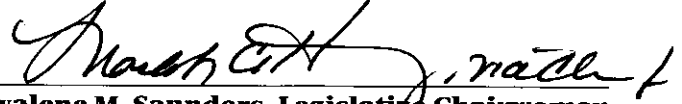

the Tohono O'odham Legislative Council.

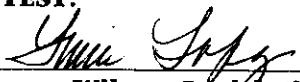
The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH

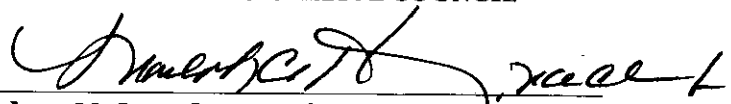

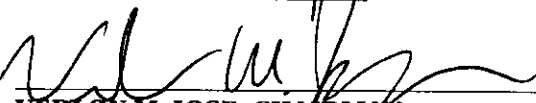
