

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 Sif-Oidak District Gaming Revenue Administration
and Community Budget Amendment No. 1)**

RESOLUTION NO. 26-203

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2026 Sif-Oidak District Gaming Revenue Budget in the amount of
13 \$4,735,610.33 was authorized by Sif-Oidak District Council Resolution No. SODC
14 25-116 and approved by Legislative Council Resolution No. 25-347; and

15 **WHEREAS,** by Sif-Oidak District Council Resolution No. SODC 26-053, the Sif-Oidak District
16 has authorized and submitted for review and approval its FY 2026 Sif Oidak
17 District Gaming Revenue Administration and Community Budget Amendment
18 No. 1, which is incorporated by this reference, and which will adjust operational
19 and/or personnel line items; and

20 **WHEREAS,** the FY 2026 Sif-Oidak District Gaming Revenue Administration and Community
21 Budget Amendment No. 1 will decrease the FY 2026 Sif-Oidak District
22 Administration Budget by \$47,249.53 from \$1,342,548.93 to \$1,295,299.40 and will
23 increase the FY 2026 Sif-Oidak District Community Budget by \$47,249.53 from
24 \$1,732,427.97 to \$1,779,677.50; and

25 **WHEREAS,** the FY 2026 Sif-Oidak District Gaming Revenue Administration and Community
26 Budget Amendment No. 1 will not change the FY 2026 Sif-Oidak District Gaming
27 Revenue Budget amount of \$4,735,610.33; and

28 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2026 Sif-Oidak District
29 Gaming Revenue Administration and Community Budget Amendment No. 1 and
30 recommends its approval.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the FY 2026 Sif-Oidak District Gaming Revenue Administration and Community Budget Amendment No. 1, which will decrease the FY 2026 Sif-Oidak District Administration Budget by \$47,249.53 from \$1,342,548.93 to \$1,295,299.40 and which will increase the FY 2026 Sif-Oidak District Community Budget by \$47,249.53 from \$1,732,427.97 to \$1,779,677.50.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the FY 2026 Sif-Oidak District Gaming Revenue Administration and Community Budget Amendment No. 1 will not change the FY 2026 Sif-Oidak District Gaming Revenue Budget amount of \$4,735,610.33.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2026 Sif-Oidak District Gaming Revenue Administration and Community Budget as amended shall be managed and expended in accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH day of JULY 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).

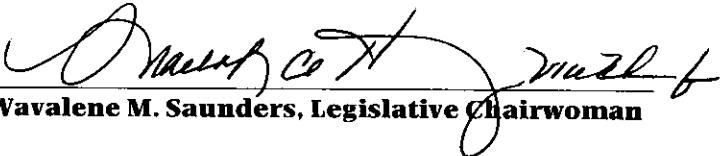

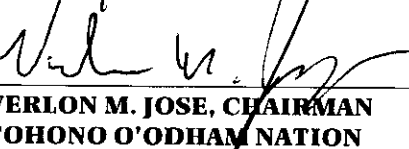

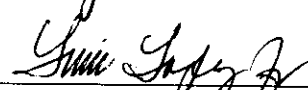
