

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 Hewel Ni'ok Corporation for Public Broadcasting Community
Service Grant Unrestricted Budget Amendment No. 2)**

RESOLUTION NO. 26-205

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2026 Hewel Ni'ok Corporation for Public Broadcasting Community Service**
8 **Grant Unrestricted Budget in the amount of \$305,853.10 was approved by**
9 **Resolution No. 25-310 and amended by Resolution No. 26-116; and**

10 **WHEREAS, the Hewel Ni'ok has prepared and submitted for review and approval its FY 2026**
11 **Hewel Ni'ok Corporation for Public Broadcasting Community Service Grant**
12 **Unrestricted Budget Amendment No. 2 which is incorporated by this reference,**
13 **and which will adjust operational and/or personnel line items and Indirect Cost**
14 **estimates; and**

15 **WHEREAS, the FY 2026 Hewel Ni'ok Corporation for Public Broadcasting Community Service**
16 **Grant Unrestricted Budget Amendment No. 2 will decrease the Hewel Ni'ok**
17 **FY2026 Corporation for Public Broadcasting Community Service Grant**
18 **Unrestricted Budget by \$1,731.60, from \$263,316.89 to \$261,585.29; and**

19 **WHEREAS, the Cultural Preservation and Budget and Finance Committees have reviewed the**
20 **FY 2026 Hewel Ni'ok Corporation for Public Broadcasting Community Service**
21 **Grant Unrestricted Budget Amendment No. 2 and recommend its approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
23 **FY 2026 Hewel Ni'ok Corporation for Public Broadcasting Community Service**
24 **Grant Unrestricted Budget Amendment No. 2, effective October 1, 2025, which**
25 **includes a \$1,731.60 decrease from \$263,316.89 to \$261,585.29, that shall be**
26 **funded by Hewel Ni'ok Corporation for Public Broadcasting Community Service**
27 **Surplus Grant funds.**

28 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
29 **Nation chairperson or any designated official is authorized to administer and**
30 **expend the FY 2026 Hewel Ni'ok Corporation for Public Broadcasting Community**
31 **Service Grant Unrestricted Budget as amended, provided that any amendments**

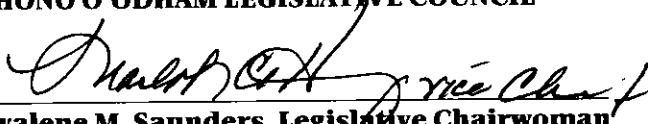

or modifications shall be submitted for prior approval by the Tohono O'odham
Legislative Council.

Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
18, 1934 (48 Stat.984).
