

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 Planning and Economic Development Department Roads Program
Road Maintenance HIP-CRRSAA Budget Amendment No. 1 No Cost Extension)**

RESOLUTION NO. 26-206

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation Legislative Council accepted the one-time**
8 **distribution of United States Bureau of Indian Affairs ("BIA") Highway**
9 **Infrastructure Program-Coronavirus Response and Relief Supplemental**
10 **Appropriation Act ("HIP-CRRSAA") funds in the amount of \$765,183.59 for**
11 **preventative and/or routine maintenance of BIA roads by Resolution No. 21-336;**
12 **and**

13 **WHEREAS, the FY 2022 Planning and Economic Development Department Roads Program**
14 **Road Maintenance Budget in the amount of \$4,655,408.59 and HIP-CRRSAA**
15 **Budget in the amount of \$765,183.59 were approved by Resolution No. 22-242; and**

16 **WHEREAS, the Nation will need to separately track and report all HIP-CRRSAA funds**
17 **expended, pursuant to the requirement of 23 U.S.C. 201(c)(6)(c) and the Nation's**
18 **Tribal Transportation Improvement Plan; and**

19 **WHEREAS, the BIA has granted a No Cost Extension to extend the project period to September**
20 **30, 2026; and**

21 **WHEREAS, the Planning and Economic Development Department Roads Program has**
22 **prepared and submitted for review and approval its FY 2026 Road Maintenance**
23 **HIP-CRRSAA Budget Amendment No. 1 No Cost Extension, which is incorporated**
24 **by this reference, and which will extend the period of performance to September**
25 **30, 2026 but will not cause a change in the \$765,183.59 budget amount; and**

26 **WHEREAS, the Agricultural and Natural Resources Committee and Budget and Finance**
27 **Committee have reviewed the FY 2026 Planning and Economic Development**
28 **Department Roads Program Road Maintenance HIP-CRRSAA Budget Amendment**
29 **No. 1 No Cost Extension and recommend its approval.**

30 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
31 **FY 2026 Planning and Economic Development Department Roads Program Road**
32 **Maintenance HIP-CRRSAA Budget Amendment No. 1 No Cost Extension effective**

May 16, 2022, through September 30, 2026, in the amount of \$765,183.59 that shall be funded by the Nation's general fund pending reimbursement from the grantor, the Bureau of Indian Affairs.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation chairperson or any designated official is authorized to administer and expend the FY 2026 Planning and Economic Development Department Roads Program Road Maintenance HIP-CRRSAA Budget as amended, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH day of JULY 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).

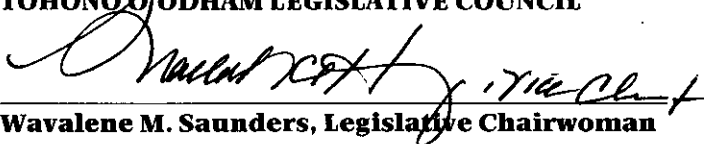

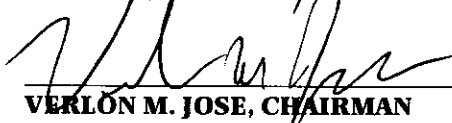
