

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 – FY 2027 Department of Education, Child Care Services
Program, Child Care and Development Fund, Discretionary
22PCAZCCDD Carry Forward Multi-Year Budget)**

RESOLUTION NO. 26-208

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Education has prepared and submitted for review and**
8 **approval its FY 2026 – FY 2027 Child Care Services Program, Child Care and**
9 **Development Fund (CCDF), Discretionary 22PCAZCCDD Carry Forward Multi-Year**
10 **Budget, which is incorporated by this reference, in the amount of \$2,993,950.77 to**
11 **be funded by the Nation's general fund pending reimbursement from the**
12 **Grantor, the United States Department of Health and Human Services,**
13 **Administration for Children and Families; and**

14 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
15 **reviewed the FY 2026 – FY 2027 Department of Education, Child Care Services**
16 **Program, CCDF Discretionary 22PCAZCCDD Carry Forward Multi-Year Budget**
17 **and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2026 – FY 2027 Department of Education, Child Care Services Program, CCDF**
20 **Discretionary 22PCAZCCDD Carry Forward Multi-Year Budget effective October 1,**
21 **2025 through September 30, 2027 in amount of \$2,993,950.77, which shall be**
22 **funded by the Nation's general fund pending reimbursement from the Grantor,**
23 **the United States Department of Health and Human Services, Administration for**
24 **Children and Families.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
26 **Nation chairperson or any designated official is authorized to administer and**
27 **expend the FY 2026 – FY 2027 Department of Education, Child Care Services**
28 **Program, CCDF Discretionary 22PCAZCCDD Carry Forward Multi-Year Budget,**
29 **provided that any amendments or modifications shall be submitted for prior**
30 **approval by the Tohono O'odham Legislative Council.**

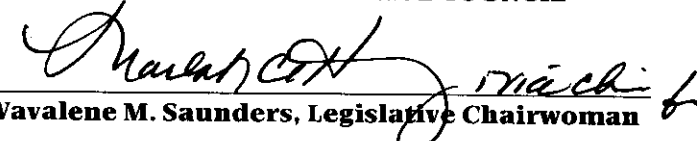

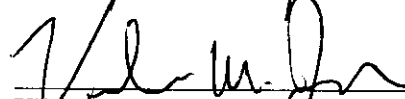
