

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 Department of Education, Education Administration
Budget Amendment No. 2)**

RESOLUTION NO. 26-210

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2026 Department of Education, Education Administration Budget in the**
8 **amount of \$734,879.54 was approved by Resolution No. 25-335, and subsequently**
9 **amended by Resolution No. 26-012; and**

10 **WHEREAS, the Department of Education has prepared and submitted for review and**
11 **approval its FY 2026 Education Administration Budget Amendment No. 2, which**
12 **is incorporated by this reference and which will adjust and create operational**
13 **line items; and**

14 **WHEREAS the FY 2026 Department of Education, Education Administration Budget**
15 **Amendment 2 will not change the original budget amount of \$734,879.54; and**

16 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
17 **reviewed the FY 2026 Department of Education, Education Administration**
18 **Budget Amendment No. 2 and recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2026 Department of Education, Education Administration Budget Amendment**
21 **No. 2 effective October 1, 2025, which will not change the original budget amount**
22 **of \$734,879.54, that shall be funded by the Nation's general fund.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2026 Department of Education, Education Administration Budget**
26 **as amended, provided that any amendments or modifications shall be submitted**
27 **for prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
29 **day of JULY 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1 (d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**

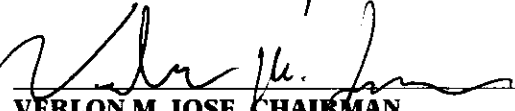

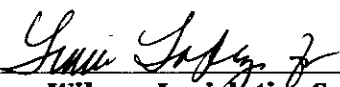
