

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 Department of Health and Human Services Community
Health Budget Amendment No. 1)**

RESOLUTION NO. 26-216

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2026 Department of Health and Human Services Community Health**
8 **Budget in the amount of \$2,853,387.70 was approved by Resolution No. 25-307;**
9 **and**

10 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
11 **review and approval its FY 2026 Community Health Budget Amendment No. 1,**
12 **which is incorporated by this reference, and which will adjust operational and/or**
13 **personnel line items; and**

14 **WHEREAS, the FY2026 Department of Health and Human Services Community Health Budget**
15 **Amendment No. 1 will decrease the Department of Health and Human Services FY**
16 **2026 Community Health Budget by \$4,761.90 from \$2,853,387.70 to \$2,848,625.80;**
17 **and**

18 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
19 **reviewed the FY 2026 Department of Health and Human Services Community**
20 **Health Budget Amendment No. 1 and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **FY 2026 Department of Health and Human Services Community Health Budget**
23 **Amendment No. 1 effective October 1, 2025, which includes a \$4,761.90 decrease**
24 **from \$2,853,387.70 to \$2,848,625.80 that shall be funded by the Self-Governance**
25 **Funding Agreement.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
27 **Nation chairperson or any designated official is authorized to administer and**
28 **expend the FY 2026 Department of Health and Human Services Community**
29 **Health Budget as amended, provided that any amendments or modifications**
30 **shall be submitted for prior approval by the Tohono O'odham Legislative Council.**

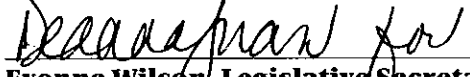
