

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2027 Department of Health and Human Services Healthy
O'odham Promotion Program Budget Amendment No. 1)**

RESOLUTION NO. 26-217

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2027 Department of Health and Human Services Healthy O'odham**
8 **Promotion Program Budget in the amount of \$2,241,130.00 was approved by**
9 **Resolution No. 25-449; and**

10 **WHEREAS, the Department of Health and Human Services Healthy O'odham Promotion**
11 **Program has prepared and submitted for review and approval its FY 2027 Budget**
12 **Amendment No. 1, which is incorporated by this reference, and which will adjust**
13 **personnel, operational, capital line items and increase indirect cost; and**

14 **WHEREAS, the FY 2027 Department of Health and Human Services Healthy O'odham**
15 **Promotion Program Budget Amendment No. 1 will increase the Department of**
16 **Health and Human Services FY 2027 Healthy O'odham Promotion Program**
17 **budget by \$1,454,431.28 from \$2,241,130.00 to \$3,695,561.28; and**

18 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
19 **reviewed the FY 2027 Department of Health and Human Services Healthy**
20 **O'odham Promotion Program Budget Amendment No. 1 and recommend its**
21 **approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
23 **FY 2027 Department of Health and Human Services Healthy O'odham Promotion**
24 **Program Budget Amendment No. 1 effective January 1, 2026, which includes a**
25 **\$1,454,431.28 increase from \$2,241,130.00 to \$3,695,561.28 that shall be funded by**
26 **the Nation's general fund pending reimbursement from the grantor, the United**
27 **States Department of Health and Human Services, Indian Health Service, Special**
28 **Diabetes Program for Indians.**

29 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
30 **Nation chairperson or any designated official is authorized to administer and**
31 **expend the FY 2027 Department of Health and Human Services Healthy O'odham**
32 **Promotion Program Budget as amended; provided that any amendments or**

modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH day of JULY 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
