

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2026 Department of Health and Human Services, Division of
Senior Services BIA Adult Care Program Budget Amendment No. 1)

RESOLUTION NO. 26-219

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2026 Department of Health and Human Services, Division of Senior
8 Services BIA Adult Care Program Budget in the amount of \$272,312.38 was
9 approved by Resolution No. 25-303; and

10 **WHEREAS,** the Department of Health and Human Services, Division of Senior Services has
11 prepared and submitted for review and approval its FY 2026 BIA Adult Care
12 Program Budget Amendment No. 1, which is incorporated by this reference and
13 which will adjust operational line items and increase indirect costs; and

14 **WHEREAS,** the FY 2026 Department of Health and Human Services, Division of Senior
15 Services BIA Adult Care Program Budget Amendment No. 1 will increase the
16 Department of Health and Human Services, Division of Senior Services FY 2026
17 BIA Adult Care Program Budget by \$165,552.51 from \$272,312.38 to \$437,864.89;
18 and

19 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
20 reviewed the FY 2026 Department of Health and Human Services, Division of
21 Senior Services BIA Adult Care Program Budget Amendment No. 1 and
22 recommend its approval.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
24 FY 2026 Department of Health and Human Services, Division of Senior Services
25 BIA Adult Care Program Budget Amendment No.1 effective October 1, 2025, which
26 includes a \$165,552.51 increase from \$272,312.38 to \$437,864.89 that shall be
27 funded by the Nation's general fund, pending reimbursement from the Bureau of
28 Indian Affairs.

29 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
30 Nation chairperson or any designated official is authorized to administer and
31 expend the FY 2026 Department of Health and Human Services, Division of Senior
32 Services BIA Adult Care Program Budget as amended, provided that any

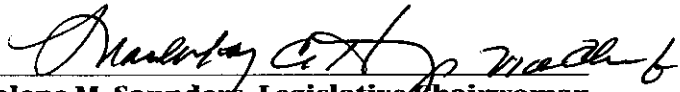

amendments or modifications shall be submitted for prior approval by the
Tohono O'odham Legislative Council.

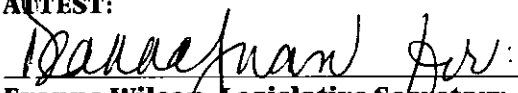
The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH

Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
18, 1934 (48 Stat.984).

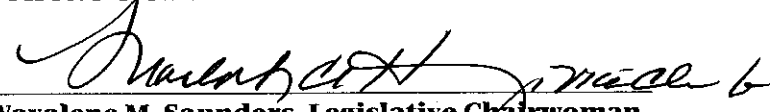

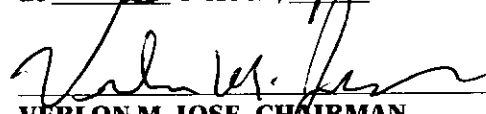
