

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 Membership Services Enrollment Committee Budget Amendment No. 1)

RESOLUTION NO. 26-225

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2026 Membership Services Enrollment Committee Budget in the amount**
8 **of \$87,520.50 was approved by Resolution No. 25-335; and**

9 **WHEREAS, the Membership Services Enrollment Committee has prepared and submitted for**
10 **review and approval its FY 2026 Budget Amendment No. 1, which is incorporated**
11 **by this reference and which will adjust operational and personnel line items; and**

12 **WHEREAS, the FY 2026 Membership Services Enrollment Committee Budget Amendment No.**
13 **1 will decrease the Membership Services FY 2026 Enrollment Committee Budget**
14 **by \$492.80 from \$87,520.50 to \$87,027.70; and**

15 **WHEREAS, the Rules and Budget and Finance Committees have reviewed the FY 2026**
16 **Membership Services Enrollment Committee Budget Amendment No. 1 and**
17 **recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2026 Membership Services Enrollment Committee Budget Amendment No. 1**
20 **effective October 1, 2025, which includes a \$492.80 decrease from \$87,520.50 to**
21 **\$87,027.70 that shall be funded by the Nation's general fund.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Nation chairperson or any designated official is authorized to administer and**
24 **expend the FY 2026 Membership Services Enrollment Committee Budget as**
25 **amended, provided that any amendments or modifications shall be submitted**
26 **for prior approval by the Tohono O'odham Legislative Council.**

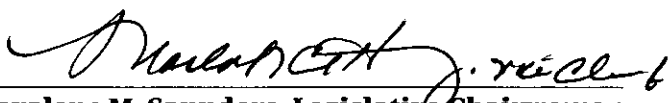
27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
28 **day of JULY 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**

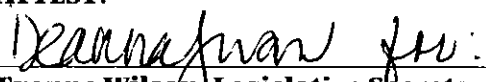

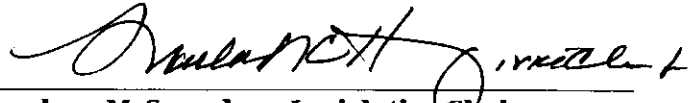

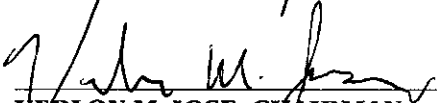
