

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 Membership Services Election Board Budget Amendment No. 1)**

RESOLUTION NO. 26-226

WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds within the exclusive control of the Tohono O'odham Nation . . . and to appropriate these funds for the benefit of the nation and its members" provided that "[a]ll expenditures of these funds shall be pursuant to appropriations or budgets" authorized by resolution or ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2)); and

WHEREAS, the FY 2026 Membership Services Election Board Budget in the amount of \$438,862.44 was approved by Resolution No. 25-335; and

WHEREAS, the Membership Services Election Board has prepared and submitted for review and approval its FY 2026 Budget Amendment No. 1, which is incorporated by this reference and which will adjust operational and personnel line items; and

WHEREAS, the FY 2026 Membership Services Election Board Budget Amendment No. 1 will decrease the FY 2026 Membership Services Election Board Budget by \$1,848.00 from \$438,862.44 to \$437,014.44; and

WHEREAS, the Rules Committee and Budget and Finance Committee have reviewed the FY 2026 Membership Services Election Board Budget Amendment No. 1 and recommend its approval.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the FY 2026 Membership Services Election Board Budget Amendment No. 1 effective October 1, 2025, which includes a \$1,848.00 decrease from \$438,862.44 to \$437,014.44 that shall be funded by the Nation's general fund.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation chairperson or any designated official is authorized to administer and expend the FY 2026 Membership Services Election Board Budget as amended, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH day of JULY 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).

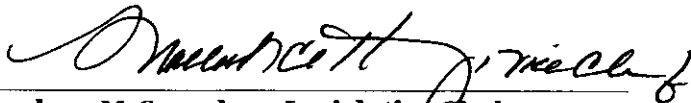

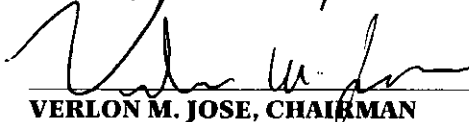
