

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Planning and Economic Development Department Roads Program
Contract for Road Maintenance Services between Tohono O'odham
Nation and Cactus Asphalt)

RESOLUTION NO. 26-227

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power to "consult, negotiate and conclude agreements and contracts on**
3 **behalf of the Tohono O'odham Nation with Federal, State and local governments**
4 **and other Indian tribes or their departments, agencies, or political subdivisions,**
5 **or with private persons or organizations on all matters within the authority of the**
6 **Tohono O'odham Council" (Constitution of the Tohono O'odham Nation, Article**
7 **VI, Section 1(f)); and**

8 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
9 **within the exclusive control of the Tohono O'odham Nation ... and to appropriate**
10 **these funds for the benefit of the nation and its members" provided that "[a]ll**
11 **expenditures of these funds shall be pursuant to appropriations or budgets"**
12 **authorized by resolution or ordinance (Constitution, Article VI, Section 1(d)(2));**
13 **and**

14 **WHEREAS, the Planning and Economic Development Department Roads Program provides**
15 **project management and contracting in architectural design, general**
16 **construction contracting, infrastructure development, and long-range facilities**
17 **planning for the Tohono O'odham Nation; and**

18 **WHEREAS, the Planning and Economic Development Department has submitted for**
19 **approval a contract for road maintenance services between Tohono O'odham**
20 **Nation and Cactus Asphalt, which is incorporated by this reference, for the Roads**
21 **Program Project PIR Road Maintenance Route 30 within the Sells and Gu Achi**
22 **Districts; and**

23 **WHEREAS, the total cost of the proposed services is \$2,546,958.00; and**

24 **WHEREAS, funds are available for the road maintenance services contract for Route 30 in the**
25 **FY 2026 Planning and Economic Development Department Roads Program**
26 **Project PIR Road Maintenance Budget, as approved by Legislative Council**
27 **Resolution No. 26-046; and**

28 **WHEREAS, the Agricultural and Natural Resources Committee has reviewed the road**
29 **maintenance services contract and recommends approval.**

30 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
31 **contract, in substantially the form attached, for road maintenance services**

between the Tohono O'odham Nation and Cactus Asphalt for the total cost of \$2,546,958.00, effective from the date of signature to September 30, 2026.

BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the Nation's chairperson or any designated official to execute the contract for engineering and construction services, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH day of JULY 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).

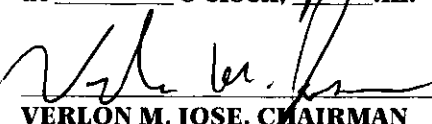

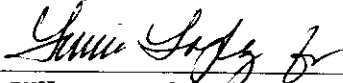
