2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2022 Planning and Economic Development Department Roads Program Gu**
8 **Vo Road and Pisinemo School Bus Route Project Budget in the amount of**
9 **\$1,023,150.00 was approved by Resolution No. 21-334; and**

10 **WHEREAS, the FY 2023 Planning and Economic Development Department Roads Program**
11 **PIR 102 Consolidated No. 29 Gu Vo Road and Pisinemo Project Budget**
12 **Amendment No. 1, which adjusted operational line items but did not change the**
13 **budget total, was approved by Resolution No. 22-425; and**

14 **WHEREAS, the Planning and Economic Development Department Roads Program has**
15 **received a no cost extension notice from the Bureau of Indian Affairs via**
16 **Modification No. 9 to extend the FY 2023 PIR 102 Consolidated No. 29 Gu Vo Road**
17 **and Pisinemo Project budget period of performance through September 30, 2027;**

19 **WHEREAS, the Planning and Economic Development Department Roads Program has**
20 **prepared and submitted for review and approval its FY 2026 – FY 2027 PIR 102**
21 **Consolidated No. 29 Gu Vo Road and Pisinemo Project Budget Amendment No. 2,**
22 **which is incorporated by this reference and which will extend the period of**
23 **performance to September 30, 2027; and**

24 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
25 **have reviewed the no cost extension and the FY 2026 – FY 2027 Planning and**
26 **Economic Development Department Roads Program PIR 102 Consolidated No. 29**
27 **Gu Vo Road and Pisinemo Project Budget Amendment No. 2 and recommend its**

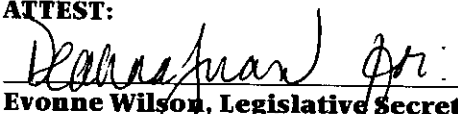

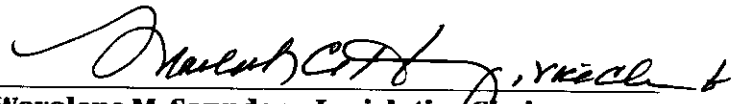

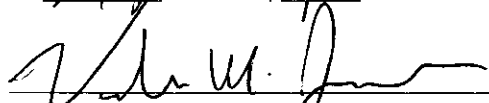
