

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022-2027 San Xavier District American Rescue Plan Act
Budget Amendment No. 3)**

RESOLUTION NO. 26-232

WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham Nation,

No district council shall expend district funds except pursuant to budgets authorized under resolutions of the district council and approved by the Tohono O'odham Council. The management of these funds shall be only by a treasurer or other authorized officer of the district council who has furnished a surety bond satisfactory to the treasurer of the Tohono O'odham Nation, and all expenditures of these funds shall be by checks signed by such treasurer or other authorized officer and the chairman or vice chairman of the district council.

; and

WHEREAS, the FY 2022-2027 San Xavier District American Rescue Plan Act ("ARPA") Budget in the amount of \$3,110,433.00 was authorized by San Xavier District Council Resolution No. SXDC 02-22-06 and approved by Legislative Council Resolution No. 22-104, and subsequently amended by Resolution Nos. 23-419 and 25-293; and

WHEREAS, by San Xavier District Council Resolution No. SXDC 05-26-08, the San Xavier District has authorized and submitted for review and approval its FY 2022-2027 ARPA Budget Amendment No. 3, which is incorporated by this reference and which will adjust operational and/or personnel line items; and

WHEREAS, the FY 2022-2027 San Xavier District ARPA Budget Amendment No. 3 will increase the FY 2022-2027 San Xavier District ARPA Budget by \$200,000.00 from \$3,110,433.00 to \$3,310,433.00; and

WHEREAS, the Budget and Finance Committee has reviewed the FY 2022-2027 San Xavier District ARPA Budget Amendment No. 3 and recommends approval.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the FY 2022-2027 San Xavier District ARPA Budget Amendment No. 3, which includes a \$200,000.00 increase from \$3,110,433.00 to \$3,310,433.00, and which shall be funded by supplemental ARPA funds.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2022-2027 San Xavier District American Rescue Plan Act Budget, as amended shall be managed and expended in accordance with Article IX, Section 7 of the

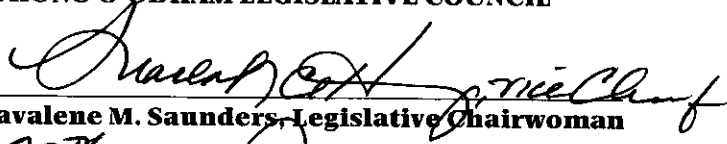

Constitution of the Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under a District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

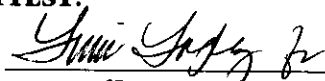

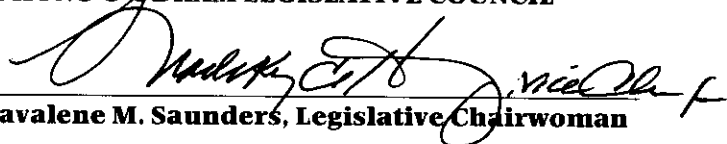
