RESOLUTION NO. 26-234

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative**
2 **Council with the power "to employ legal counsel for the protection and**
3 **advancement of the Tohono O'odham Nation..." (Constitution, Article VI, Section**
4 **2(a)); and**

5 **WHEREAS, the Office of Attorney General has prepared and submitted for review and**
6 **approval the FY2026 – FY2028 Attorney Contract between James Andrew Jolley,**
7 **Esq. of the law firm Prescott Law Group, PLC and the Office of Attorney General**
8 **("Attorney Contract"), which is incorporated herein by reference, for legal**
9 **services related to the prosecution of the Nation's criminal cases; and**

10 **WHEREAS, fees for services provided under the Attorney Contract will be paid by the Office**
11 **of Attorney General budget; and**

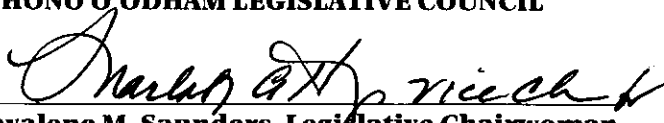
12 **WHEREAS, the Budget & Finance and Domestic Affairs Committees have reviewed the**
13 **contract and recommends approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
15 **the FY2026 – FY2028 Attorney Contract between James Andrew Jolley, Esq. of the**
16 **law firm Prescott Law Group, PLC and the Office of Attorney General in**
17 **substantially the form attached.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes and directs**
19 **the Nation's chairperson to execute the Attorney Contract, provided that any**
20 **amendments to the Attorney Contract shall be submitted for prior approval by**
21 **the Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH**
23 **day of JULY 2026 at a meeting at which a quorum was present with a vote of 3,187.95 FOR;**
24 **133.15 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the**
25 **Council by Article VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted**
26 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
27 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
28 **Act of June 18, 1934 (48 Stat.984).**
