

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 Baboquivari District Artesia/Little Tucson Community
Budget Amendment No. 2)**

RESOLUTION NO. 26-240

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only**
6 **by a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

12 **WHEREAS, the FY 2026 Baboquivari District Budget in the amount of \$5,373,205.73 was**
13 **authorized by Baboquivari District Council Resolution No. 2026-B-79 and**
14 **approved by Legislative Council Resolution No. 25-339, and subsequently**
15 **amended by Legislative Council Resolution No. 25-424 in the amount of**
16 **\$5,451,425.35; and**

17 **WHEREAS, by Baboquivari District Council Resolution No. 2026-B-13, the Baboquivari**
18 **District has authorized and submitted for review and approval its FY 2026**
19 **Baboquivari District Artesia/Little Tucson Community Budget Amendment No.**
20 **2, which is incorporated by this reference and which will adjust operational**
21 **and/or personnel line items; and**

22 **WHEREAS, the FY 2026 Baboquivari District Artesia/Little Tucson Community Budget**
23 **Amendment No. 2 will not change the FY 2026 Baboquivari District Artesia/Little**
24 **Tucson Community Budget amount of \$533,820.57; and**

25 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2026 Baboquivari**
26 **District Artesia/Little Tucson Community Budget Amendment No. 2 and**
27 **recommends its approval.**

28 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
29 **FY 2026 Baboquivari District Artesia/Little Tucson Community Budget**
30 **Amendment No. 2 effective October 1, 2025, which will not change the FY 2026**

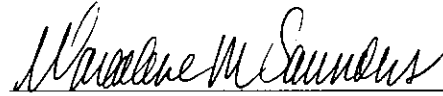

\$533,820.57, nor will it change the overall FY 2026 Baboquivari District Budget amount of \$5,451,425.35.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2026 Baboquivari District Artesia/Little Tucson Community Budget as amended shall be managed and expended in accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD day of AUGUST 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).

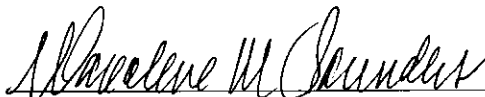

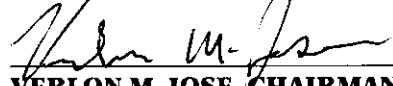

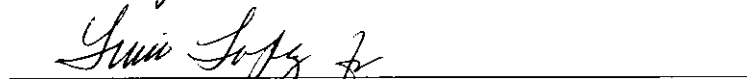
