

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Accepting Amendment No. 2 to the Arizona Department of Economic Security Planned Social Services Title XX Block Grant Intergovernmental Agreement)

RESOLUTION NO. 26-243

1 **WHEREAS, the Tohono O'odham Nation vests the Tohono O'odham Legislative Council with**
2 **the power "to consult, negotiate, and conclude agreements and contracts on**
3 **behalf of the Tohono O'odham Nation with Federal, State, and local governments**
4 **and other Indian tribes or their departments, agencies, or political**
5 **subdivisions, or with private persons or organizations on all matters within the**
6 **authority of the Tohono O'odham Council." (Constitution, Article VI, Section 1(f));**
7 **and**

8 **WHEREAS, the Intergovernmental Agreement ("IGA") between the Tohono O'odham Nation**
9 **("Nation") and the Arizona Department of Economic Security ("ADES") for the**
10 **Planned Social Services Title XX Block Grant, ADES Contract Number DI125-**
11 **002415, was approved by Resolution No. 24-386 for the period from the date of**
12 **the last signature on the IGA through June 30, 2025 in the amount of \$106,285.00;**
13 **and**

14 **WHEREAS, Amendment No. 1 to the IGA was approved by the Tohono O'odham Legislative**
15 **Council by Resolution No. 25-208 which extended the IGA from July 1, 2025**
16 **through June 30, 2026, which did not change the reimbursement ceiling of**
17 **\$106,285.00; and**

18 **WHEREAS, the Department of Education has submitted for review and approval**
19 **Amendment No. 2 to the IGA, which is incorporated by this reference, which will**
20 **not change the reimbursement ceiling of \$106,285.00, for the period of July 1,**
21 **2026 through June 30, 2027; and**

22 **WHEREAS, the Human Resources Development Committee has reviewed Amendment No. 2**
23 **to the IGA and recommend its approval.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
25 **and accepts Amendment No. 2 to the Arizona Department of Economic Security**
26 **Planned Social Services Title XX Block Grant Intergovernmental Agreement,**
27 **which will extend the IGA for the period of July 1, 2026 through June 30, 2027.**

28 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
29 **O'odham Nation chairperson or any designated official is authorized to execute**
30 **Amendment No. 2 to the IGA, provided that any further amendments or**
31 **modifications shall be submitted for prior approval by the Tohono O'odham**
32 **Legislative Council.**

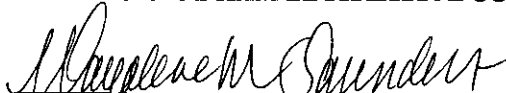

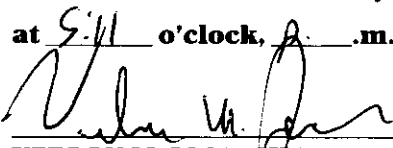
