RESOLUTION NO. 26-248

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members**
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Articles VI and VII of the Nation's Enrollment Ordinance, the**
6 **Enrollment Committee shall review membership applications and make a**
7 **written recommendation to the Tohono O'odham Legislative Council to approve**
8 **or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment**
9 **Ordinance); and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**
11 **O'odham Legislative Council shall determine eligibility for membership or**
12 **adoption; and**

13 **WHEREAS, the Enrollment Program has received official documents reflecting the legal**
14 **name changes of enrolled members as a result of marriage, divorce, legal**
15 **adoption, or for other reasons; and**

16 **WHEREAS, the Enrollment Committee recommends that Resolution Nos. 83-83, 127-83, 138-**
17 **87, 92-208, 02-280, 08-664, 09-330, 10-439, and 18-098 be amended to reflect the**
18 **legal name changes of members identified in the August 2026 Legal Enrollment**
19 **Resolution Summary, which is incorporated by this reference.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**
21 **Resolution Nos. 83-83, 127-83, 138-87, 92-208, 02-280, 08-664, 09-330, 10-439, and**
22 **18-098 are amended upon the effective date of those resolutions to reflect the**
23 **legal name changes of members identified in the August 2026 Legal Enrollment**
24 **Resolution Summary.**

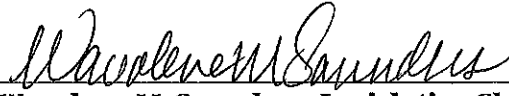
25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**

28 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**
29 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**
30 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**
31 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**

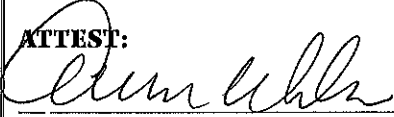

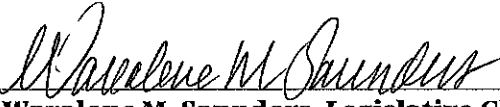

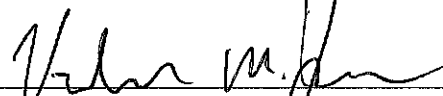
