RESOLUTION NO. 26-249

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members**
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the**
6 **Enrollment Committee shall review membership applications and make a**
7 **written recommendation to the Tohono O'odham Legislative Council to approve**
8 **or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment**
9 **Ordinance); and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**
11 **O'odham Legislative Council shall determine eligibility for membership or**
12 **adoption; and**

13 **WHEREAS, the Enrollment Program has determined that a number of resolutions**
14 **approving membership and adoption applications misspelled or incorrectly**
15 **listed the names of members and/or incorrectly listed enrollment numbers; and**

16 **WHEREAS, the Enrollment Committee recommends that Resolution Nos. 423-90, 94-003, 97-**
17 **221, 98-357, 98-429, 08-411, 09-101, 09-330, 10-001, 10-401, and 12-085 be**
18 **amended to reflect the correct name and/or enrollment number for the**
19 **members identified in the August 2026 Corrected Enrollment Resolution**
20 **Summary, which is incorporated by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**
22 **Resolution Nos. 423-90, 94-003, 97-221, 98-357, 98-429, 08-411, 09-101, 09-330, 10-**
23 **001, 10-401, and 12-085 are amended upon the effective date of those resolutions**
24 **to reflect the correct names and/or enrollment number of members identified**
25 **in the August 2026 Corrected Enrollment Resolution Summary.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**
27 **day of AUGUST 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
29 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**
30 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**
31 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**

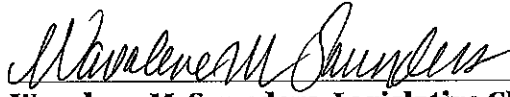

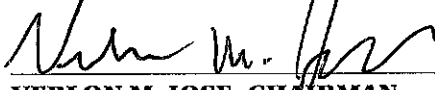

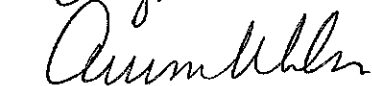
